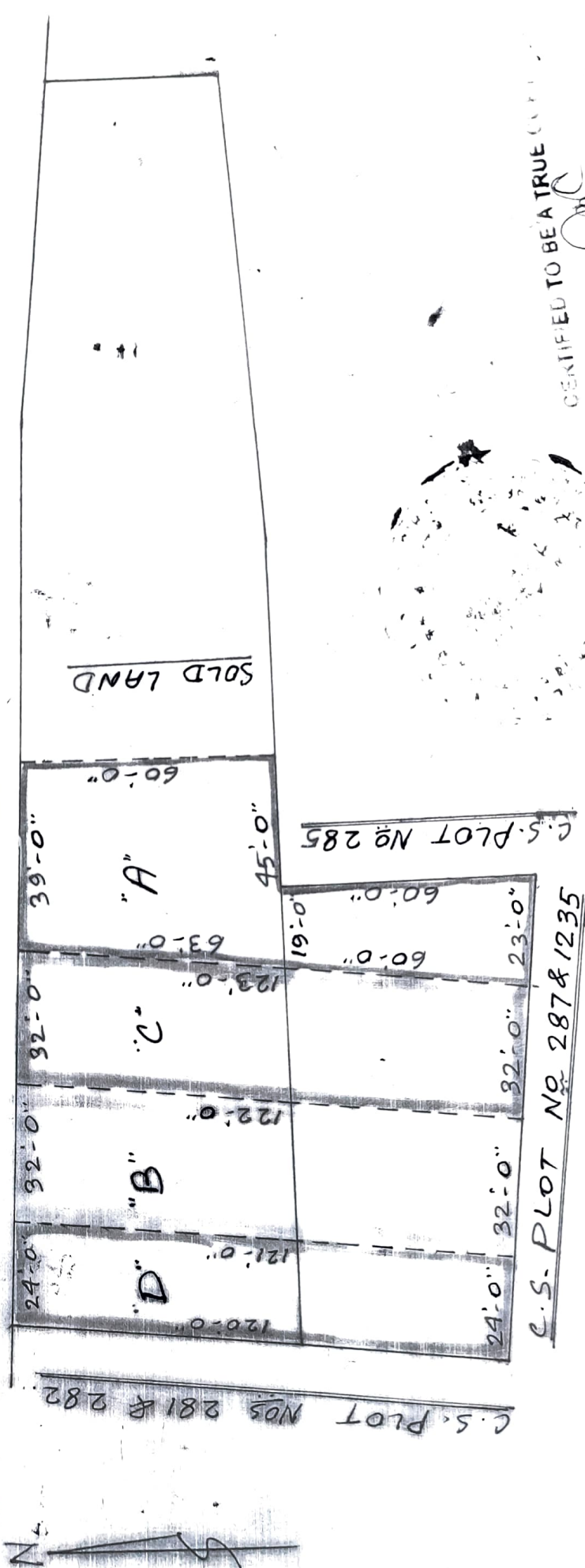
PARTITION PLAN OF C.S. PLOT NOS 283 & 284. MOUZA-BAISHNAB GR.

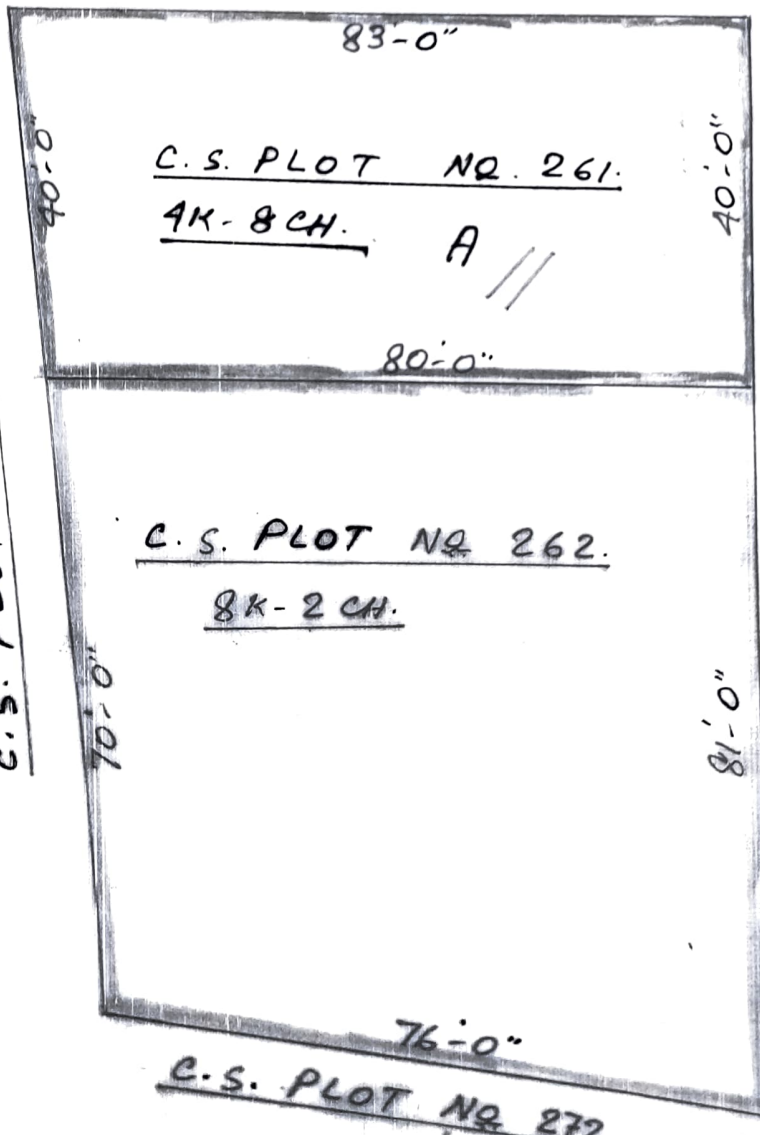

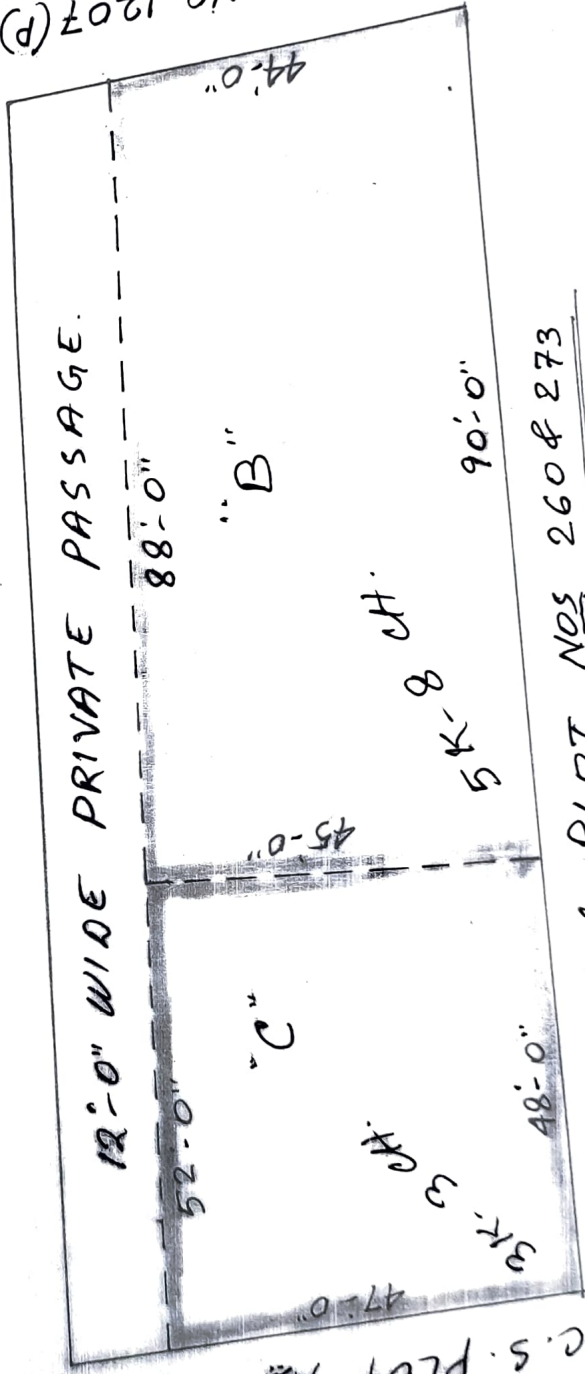

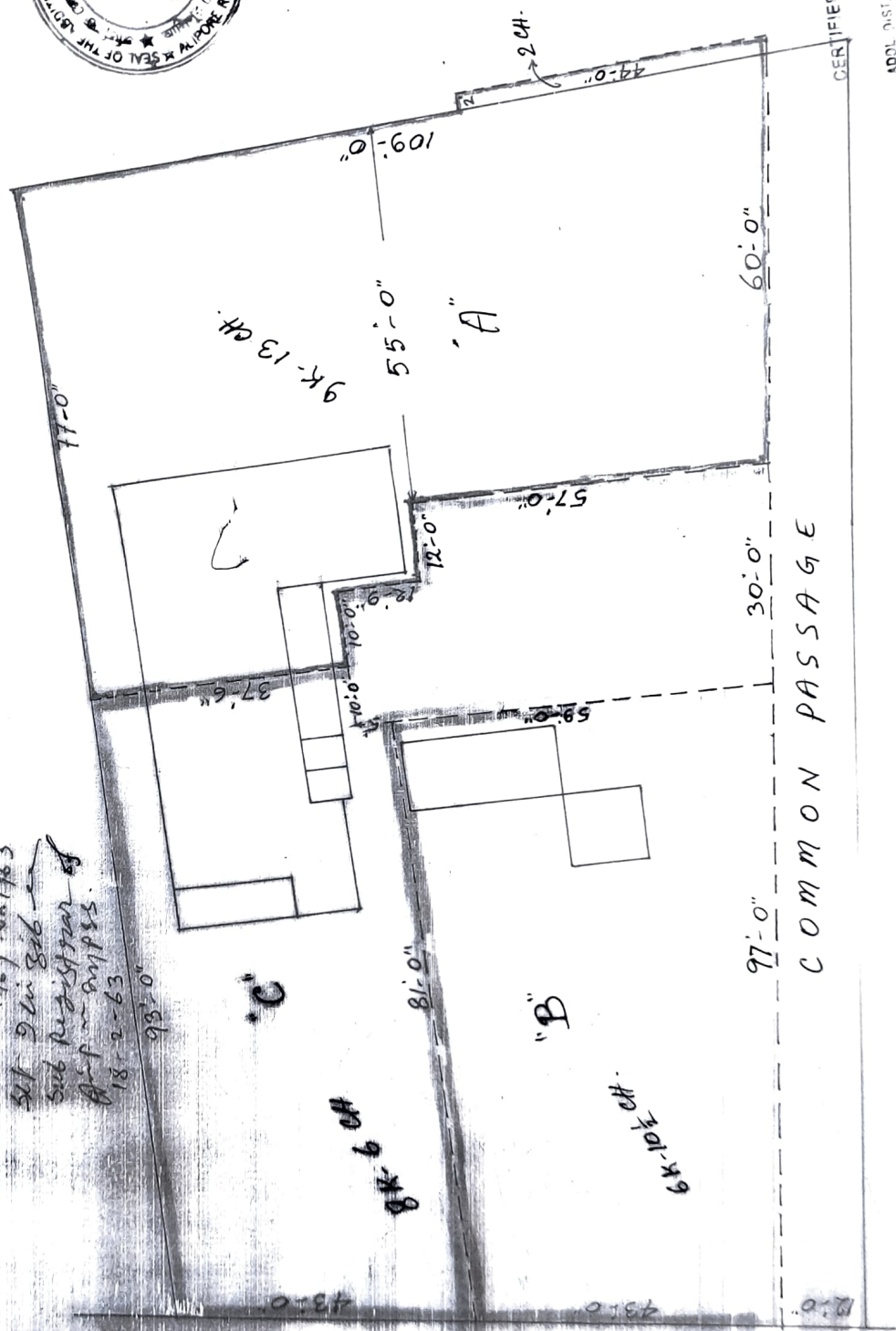
