- b) "Rules" Means the West Bengal Housing Industry Regulation Rules 2018 made under the West Bengal Housing Industry Regulation Act 2017.
- c) "Regulation" means the Regulations made under the West Bengal Housing Industry Regulation Act 2017.
- d) "Section" means a section of the Act.

WHEREAS:

- A. By a Deed of Conveyance dated 26th September 1975 made between the Trustees for the Improvement of Calcutta (therein referred to as "the Board") of the One Part and Asok Kumar Banerjee alias Asok Banerjee (therein referred to as "the Purchaser") of the Other part and registered in the Office of the Sub-Register Sealdah, 24 Pargana, recorded in Book No. I, Volume 61, Pages, 100 to 104, being Deed No. 2080 for the year 1975, the Board therein granted conveyed and transferred in favour of the Purchaser therein **ALL THAT** a revenue free land containing an area of **410.66 sq. mt.** equivalent to **06 (Six) cottah 02 (Two) Chittak 10.3 (Ten point Three) Sq. Ft.**, more or less situated at Plot No.1 and 2 of the surplus land in Calcutta Improvement Scheme VI-M (S), formed out of old Premises No. 104, Narkeldanga Main Road, 107, Narkeldanga Main Road, Kankurgachi Road and comprised in Holding Nos. 78 (Por.), 48a(Por) and 366 in Sub-Divisional 11, 12 and 12, Division 5, Dihi Panchannogram, Police Station - Phoolbagan, within the ambit of Kolkata Municipal Corporation, under Assessee No. 110300200229, Post Office - Kankurgachi, Sub-Registration office Sealdah in the District of 24 Parganas, TOGETHER WITH ALL liberties, privileges, easement rights, appurtenances and appurtenances whatsoever of the said land hereditaments, free from all encumbrances absolutely and forever at or for the

agreed consideration and the purchaser therein made payment of part consideration and agreed to secure the balance sum by creating mortgage/charge of the Land in favour of the Board.

- B. By a Security Deed dated 26th September 1975 made between The Trustees for the Improvement of Calcutta and Asok Kumar Banerjee alias Asok Banerjee and registered with the Sub-Register Sealdah in Book No.1, Volume No. 58, Pages 216 to 223, Being Deed No. 2081 for the year 1975, the said Asok Kumar Banerjee alias Asok Banerjee created mortgage/charge over the Land as security for due payment of the balance consideration money due and payable by him under the Deed of Conveyance dated 26th September, 1975.
- C. By an Indenture dated 9th January 1985 made between The Trustees for the Improvement of Calcutta (therein referred to as "the Board") of the One Part and Asok Kumar Banerjee alias Asok Banerjee (therein referred to as "the Releasee") of the Other part and registered in the office of Sub-Registrar Sealdah, 24 Parganas, recorded in Book No.1, Volume No.3, Pages 349 to 356, Being No. 136 for the year 1985, the Releasee made payment of the loan and interest due to the Board and the Board upon receipt of the entire principal amount with all interest due under the said Security Deed dated 26th September 1975, released, exonerated and forever discharged the Releasee from the Security Deed and the Land, morefully described in the Schedule therein, absolutely and forever. Thus Asok Kumar Banerjee alias Asok Banerjee became the absolute owner of the property morefully mentioned in the schedule hereunder written . He also mutated his name in the records of the then Calcutta Municipal Corporation now Kolkata Municipal corporation as owner of the said Property under Assessee No. 110300200229 and has been paying taxes regularly.
- D. The said Asok Kumar Banerjee alias Asok Banerjee obtained plan from the then Calcutta Municipal Corporation now Kolkata Municipal corporation for construction of a residential building with mezzanine floor on his Land Vide Building sanctioned Plan dated 24.08.1977.
- E. The said Dr. Asok Kumar Banerjee alias Asok Banerjee constructed a G + One storied residential building with Mezzanine floor on the Land, hereinafter jointly referred to as the said "Property") and also mutated his name in the records of the then Calcutta Municipal Corporation now Kolkata Municipal corporation as owner of the said Property under Assessee No. 110300200229 and has been paying taxes regularly.
- F. The said Dr. Asok Kumar Banerjee alias Asok Banerjee out of natural love and affection desire towards his daughter Nilanjana Banerjee, gifted the SAID PROPERTY i.e. **ALL THAT** a piece and parcel of land measuring **410.66 sq. mts.** more or less equivalent to **06 Cottah 02 Chittaks 10.30 Sq. Ft.** more or less, together with 40 years old **G + One storied** residential house measuring **4052.15 sq. ft. (built up area more or less** (ground floor measuring 1930.03 sq.ft., First Floor measuring 2122.12 sq.ft.) at **Premises No. 1 CIT Road, Scheme No. VI-M(S), Kolkata - 700 054**, formed out of old Premises No. 104, Narkeldanga Main Road, 107, Narkeldanga Main Road, Kankurgachi Road and comprised in Holding Nos. 78 (Por.), 48a(Por) and 366 in Sub-Divisional 11, 12 and 12, Division 5, Dihi Panchannogram, Police Station - Phoolbagan, within the ambit of Kolkata Municipal Corporation, under Assessee No. 110300200229, Post Office -

Kankurgachi, Sub-Registration office Sealdah in the District of 24 Parganas South, TOGETHER WITH ALL liberties, privileges, easement rights, appurtenances and appurtenances whatsoever of the said land hereditaments, free from all encumbrances, by dint of a Deed of Gift dated 07th July, 2022, registered at the office of Additional Registrar of Assurances-II, Kolkata, recorded in Book No. I, Volume No. 1902-2022, Pages 323352 to 323374, being Deed No. 190207847, for the year 2022.

- G. The said Nilanjana Banerjee has duly recorded and mutated her name as owner in respect of the said property in the office of the Kolkata Municipal Corporation under Assessee No. 110300200229, the Premises No. as recorded with the KMC being P1, C.I.T. Scheme VI M/S/, and has been regularly paying all municipal taxes in respect thereof.
- H. The said Nilanjana Banerjee, became the absolute joint Owners, well seized and possessed of and sufficiently entitled to **ALL THAT** a piece and parcel of land measuring **410.66 sq. mts.** more or less equivalent to **06 Cottah 02 Chittaks 10.30 Sq. Ft.** more or less, together with 40 years old **G + One storied** residential house measuring **4052.15 sq. ft. (built up area more or less** (ground floor measuring 1930.03 sq.ft., First Floor measuring 2122.12 sq.ft.) at **Premises No. 1 CIT Road, Scheme No. VI-M(S), Kolkata - 700 054**, formed out of old Premises No. 104, Narkeldanga Main Road, 107, Narkeldanga Main Road, Kankurgachi Road and comprised in Holding Nos. 78 (Por.), 48a(Por) and 366 in Sub-Divisional 11, 12 and 12, Division 5, Dihi Panchannogram, Police Station - Phoolbagan, within the ambit of Kolkata Municipal Corporation, under Assessee No. 110300200229, Post Office - Kankurgachi, Sub-Registration office Sealdah in the District of 24 Parganas South, TOGETHER WITH ALL liberties, privileges, easement rights, appurtenances and appurtenances whatsoever of the said land hereditaments, free from all encumbrances, hereinafter referred to as the **SAID PROPERTY**, sold transferred and conveyed unto and in favour of AJMIR TOWER PRIVATE LIMITED, represented by its Directors Raju Naskar, the OWNER/PROMOTER, herein, by dint of a Deed of Conveyance dated 16.01.2026, registered at the office of Additional District Sub-Registrar, Sealdah, recorded in Book No. I, Volume No. 1606-2026, Page from 3526 - 3554, being No. 160600130 for the year 2026.
- I. The said OWNER/PROMOTER recorded and mutated its name in the records of Kolkata Municipal Corporation, in respect of **Premises No. 1 CIT Road, Scheme No. VI-M(S), Kolkata - 700 054**, (as per KMC record P1, C.I.T. Scheme VI M/S/), under Assessee No. 110300200229.
- J. The Promoter is fully competent to enter into this Agreement and all the legal formalities with respect to the right, title and interest of the Promoter regarding the said land on which Project is to be constructed have been completed;
- K. The Promoter has applied for sanction Plan before the said Kolkata Municipal Corporation and obtained sanction building plan being Permit No. _____ dated _____ for construction of G+4 storied Building, by payment of necessary fees and charges and started construction by demolishing the existing structure thereon.

- L. The promoter has obtained the final layout plan, sanctioned plan, specification and approvals for the project and also for the apartment, plot or building, as the case may be from Kolkata Municipal Corporation. The promoter agrees and undertakes that it shall not make any changes to these approved plans except in strict compliance with section 14 of the Act and other laws as applicable.
- M. The Promoter has applied to register the project under the provisions of the Act with the West Bengal REAL ESTATE REGULATORY AUTHORITY at West Bengal under RERA REGISTRATION NO. : _____ dated _____ .
- N. The Allottee had applied for an apartment in the Project vide application no. _____ dated _____ and has been allotted apartment no. _____ having carpet area of _____ square feet, type _____, on _____ floor under the name and style of '**AJMIR IRIS**', along with garage/closed parking no. _____ admeasuring _____ square feet in the _____ [Please insert the location of the garage/closed parking], as permissible under the applicable law and of pro rata share in the common areas ("Common Areas") as defined under clause (n) of Section 2 of the Act (hereinafter referred to as the "Apartment" more particularly described in Schedule A and the floor plan of the apartment is annexed hereto and marked as Schedule B);
- O. The Parties have gone through all the terms & conditions set out in this Agreement and understood the mutual rights and obligations detailed herein.
- P. The Parties hereby confirm that they are signing this Agreement with full knowledge of the all laws, rules, regulations, notifications etc. applicable to the Project.
- Q. The Parties, relying on the confirmations, representations and assurances of each other to faithfully abide by all the terms, conditions and stipulations contained in this Agreement and all applicable laws, are now willing to enter into this Agreement on the terms and conditions appearing hereinafter;
- R. In accordance with the terms and conditions set out in this Agreement and as mutually agreed upon by and between the Parties, the Promoter hereby agrees to sell and the Allottee hereby agrees to purchase the [Apartment] and the garage/covered parking (if applicable).

NOW THEREFORE, in consideration of the mutual representations, covenants, assurances, promises and agreements contained herein and other good and valuable consideration, the Parties agree as follows:

1. TERMS:

Subject to the terms and conditions as detailed in this Agreement, the Promoter agrees to sell to the Allottee and the Allottee hereby agrees to purchase, the [Apartment/Plot] as specified in paragraph H;

1. **Explanation:**

- (i) The Total Price above includes the booking amount paid by the allottee to the Promoter towards the [Apartment]
- (ii) The Total Price above excludes Taxes (consisting of tax paid or payable by the Promoter by way of G.S.T. and Cess or any other similar taxes which may be levied, in connection with the construction of the Project payable by the Promoter, by whatever name called) upto the date of the handing over the possession of the Apartment
Provided that in case there is any change/ modification in the taxes, the subsequent amount payable by the Allottee(s) to the Promoter shall be increased/ reduced based on such change/ modification.

The Total Price is escalation free, save and except increases which the Allottee(s) hereby agree to pay, due to increase on account of development charges payable to the competent authority and/or any other increase in charges which may be levied or imposed by the competent authority, from time to time. The Promoter undertakes and agrees that while raising a demand on the Allottee(s) for increase

in development charges, cost/charges imposed by the competent authorities, the Promoter shall enclose the said notification/ order/ rules/ regulations to that effect along with the demand letter being issued to the Allottee(s), which shall only be applicable on subsequent payments:

- 1.5 The allottee(s) shall make the payment as per the payment plan set out in Schedule C ("Payment Plan").
- 1.6 The Promoter shall confirm the final carpet area that has been allotted to the Allottee after the construction of the Said Block/Building is complete and the completion certificate is granted by the competent authority, by furnishing details of the changes, if any, in the carpet area. The Total Price payable for the carpet area shall be recalculated upon confirmation by the Promoter. If there is reduction in the carpet area within the defined limit then the Promoter shall refund the excess money paid by the Allottee within forty- five days with annual interest at the rate prescribed in the Rules, from the date when such an excess amount was paid by the Allottee. If there is any increase in the carpet area allotted to the Allottee, the Promoter shall demand that from the Allottee as per the next milestone of the Payment Plan. All these monetary adjustments shall be made at the same rate per square feet as agreed in this Agreement.
- 1.7 Subject to the terms contained in this Agreement, the Promoter agrees and acknowledges that the Allottee shall have the following rights to the Said Apartment And Appurtenances:
 - 1.7.1 The Allottee(s) shall have exclusive ownership of the Apartment;
 - 1.7.2 The Allottee(s) shall also have undivided proportionate share in the common areas (describe in the **Schedule E** below). Since the share/ interest of Allottee(s) in the common areas is undivided and cannot be divided or separated, the Allottee(s) shall use the common areas, along with other occupants and maintenance staff etc., without causing any inconvenience or hindrance to them. Further, the right of the Allottee to use the Common Areas/Whole Project Included Amenities shall always be subject to the timely payment of maintenance charges and other charges as applicable. It is clarified that the Promoter shall handover the common areas (described in the **Schedule E** below) to the association of allottees after duly obtaining the completion certificate from the competent authority as provided in the Act.
 - 1.7.3 That the computation of the price of the Apartment includes recovery of price of land, construction of, [not only the Apartment but also], the common areas, internal development charges, external development charges, taxes, cost of providing electric wiring, electrical connectivity

to the Apartment, lift, water line and plumbing, finishing with paint, marbles, tiles, doors, windows, fire detection and firefighting equipment in the common areas, maintenance charges etc. and includes cost for providing all other facilities, amenities and specification to be provided within the Apartment and the Project;

- 1.8 It is made clear by the Promoter and the Allottee agree that the Apartment shall be treated as a single indivisible unit for all purposes. It is agreed that the Project is an independent, self-contained Project covering the said Land and is not a part of any other project or zone and shall not form a part of and/or linked/ combined with any other project in its vicinity or otherwise accept for the purpose of integration of infrastructure for the benefit of the Allottee. It is clarified that Project's facilities and amenities shall be available only for use and enjoyment of the Allottee(s) as expressly mentioned in this Agreement.
- 1.9 The Promoter agrees to pay all outgoings/ dues before transferring the physical possession of the Apartment to the Allottee(s) which it has collected from the Allottee(s), for the payment of outgoings/ dues (including land cost, ground rent, municipal or other local taxes, charges for water or electricity, maintenance charges, including mortgage loan and interest on mortgages or other encumbrances and such other liabilities payable to competent authorities, banks and financial institutions, which are related to the Project). If the Promoter fails to pay all or any of the outgoings/ dues collected by it from the Allottee(s) or any liability, mortgage loan and interest thereon before transferring the Apartment to the Allottee(s), the Promoter agrees to be liable, even after the transfer of the property, to pay such outgoings/ dues and penal charges, if any, to the authority or person to whom they are payable and be liable for the cost of any legal proceedings which may be taken therefore by such authority or person.

The Allottee has paid a sum of **10% of the Total Price** as booking amount being part payment towards the Total Price of the [Apartment] at the time of application the receipt of which the Promoter hereby acknowledges and the Allottee hereby agrees to pay the remaining price of the [Apartment] as prescribed in the payment plan at [Schedule C] as may be demanded by the Promoter within the time and manner specified therein.

Provided that if the Allottee(s) delays in payment towards any amount which is payable, they shall be liable to pay interest at the rate prescribed in the Rules.

2. **MODE OF PAYMENT:**

2.1 Subject to the terms of the agreement and the Promoter abiding by the construction milestones as expressly mentioned in this Agreement, the Allottee

shall make all payments, on written demand by the Promoter, within the stipulated time as mentioned in the payment plan through account payee cheque / demand draft/ banker's cheque or online payment (as applicable) in favour of

3. **COMPLIANCE OF LAWS RELATING TO REMITTANCES:**

3.1. The Allottee, if residence outside India, shall be solely responsible for complying with the necessary formalities as laid down in Foreign Exchange Management Act, 1999 ('FEMA'), Reserve Bank of India Act, 1934 ('RBI' Act) and the Rules and Regulation made there under or any statutory amendments or modifications made thereof and all others applicable laws including that of remittance of payment, acquisition/ sale/ transfer of immovable properties in India etc. and provide the Promoter with such permission, approval which would enable the Promoter to fulfil its obligations under this Agreement. Any refund, transfer of security, if provided in terms of the Agreement shall be made in accordance with the provisions of Foreign Exchange Management Act, 1999 or statutory enactments or amendments thereof and the Rules and Regulation of the Reserve Bank of India or any other applicable law. The Allottee understands and agrees that in the event of any failure on his/ her / their part to comply with the applicable guidelines issued by the Reserve Bank of India, he/she/they may be liable for any action under Foreign Exchange Management Act, 1999 or other laws as applicable, as amended from time to time.

3.2. The Promoter accepts no responsibility in regard to matters specified in Para 3.1 above. The Allottee shall keep the Promoter fully indemnified and harmless in this regards. Whenever there is any change in the residential status of the Allottee subsequent to the signing of this Agreement, it shall be the sole responsibility of the Allottee to intimate the same in writing to the Promoter immediately and comply with necessary formalities if any, under the applicable laws. The Promoter shall not be responsible towards any third party making payment/remittances on behalf of Allottee and such third party shall not have any right in the application/allotment of the said Apartment apply for herein in any way and the Promoter shall be issuing the payment receipts in favour of the Allottee only.

4. **ADJUSTMENT/ APPROPRIATION OF PAYMENTS:**

The Allottee authorized the Promoter to adjust/ appropriate all payments made by him/her/them under any head(s) of dues against lawful outstanding of the Allottee against the [Apartment], if any, in his/ her/their name/s and the Allottee undertakes not to object/ demand/ direct the Promoter to adjust his payments in any manner.

5. **TIME IS ESSENCE :**

Time is of essence for the Promoter as well as the Allottee. The Promoter shall abide by the time schedule for completing the Project as disclosed at the time of registration of the Project with the Authority and towards handing over the Said

Apartment to the Allottee and the Common Areas of the Real Estate Project (described in the Schedule E below) to the association of Allottee, upon its formation and registration. Similarly, the Allottee shall make timely payments of the instalment and other dues payable by him/her and meeting the other obligations under the Agreement subject to the simultaneous completion of construction by the Promoter as provided in Schedule C i.e. the Payment Plan.

6. **CONSTRUCTION OF THE PROJECT/APARTMENT:**

The Allottee has seen the proposed for layout plan, specifications, amenities and facilities of the Apartment and accepted the floor plan, payment plan and the specification, amenities and facilities annexed along with this Agreement which has been approved by the competent authority, as represented by the Promoter. The Promoter shall develop the Project in accordance with the said layout plans, floor plans and specifications, amenities and facilities, Subject to the terms in this Agreement, the Promoter undertakes to strictly abide by such plans approved by the competent authorities and shall also strictly abide by the bye-laws, FAR, and density norms and provisions prescribed by the Housing Industry Regulation Act and shall not have an option to make any variation/ alteration/ modification in such plans, other than in the manner provided under the Act, and breach of this term by the Promoter shall constitute a material breach of this Agreement.

7. **POSSESSION OF THE APARTMENT:**

7.1. **Schedule for possession of the said [Apartment] –**

The Promoter agrees and understands that timely delivery of possession of the [Apartment] to the Allottee and the common areas to the Association of allottee (upon its formation and registration) or the competent authority, as the case may be, is the essence of the Agreement. The Promoter assures to handover possession of the [Apartment] along with ready and complete common areas with all specifications, amenities and facilities of the Project in place on or before _____ if unless there is delay or failure due to war, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature affecting the regular development of the Real Estate Project; or any further delay(s) beyond the control of the Promoter due to epidemic, quarantine restriction, state or nation wide lockdown, including any future disruptions due to the coronavirus disease or other circumstances deemed by the Authority to be force majeure events **(Force Majeure)**. If, however, the completion of Project is delayed due to the Force Majeure conditions then the Allottee agrees that the Promoter shall be entitled to the extension of time for delivery of possession of the [Apartment].

Provided that such Force Majeure conditions are not of a nature which make it impossible for the contract to be implemented. The Allottee(s) agrees and confirms that, in the event it becomes impossible for the Promoter to implement the project due to Force Majeure conditions, then this allotment shall stand terminated and the Promoter shall refund to the Allottee(s) the entire amount received by the Promoter from the Allotment within 45 days from that date. The Promoter shall intimate the Allottee about such termination at least thirty days

prior to such termination. After refund of the money paid by the Allottee, the Allottee agreed that he/ she shall not have any rights, claims etc. against the Promoter and the Promoter shall be released and discharged from all its obligations and liabilities under this Agreement.

The Possession Date has been accepted by the Allottee. However, if the Said Apartment is made ready prior to the Completion Date, the Allottee undertakes(s) and covenant (s) not to make or raise any objection to the consequent preponement of his/her /their/its payment obligations, having clearly agreed and understood that the payment obligations of the Allottee are linked inter alia to the progress of construction, and the same is not a time linked plan.

Notwithstanding anything elsewhere to the contrary herein contained, it is expressly agreed understood and clarified that if at any time, , the customer is required to pay any stamp duty, registration fee, legal fees, other expenses, etc., which becomes payable therefor, then the same shall be borne paid and discharged by the Allottee of the Project (including the Allottee herein) proportionately and the Promoter and/or the Owners shall not be liable therefor in any manner whatsoever and the Allottee and the other Allottee shall keep the Promoter and the Owners fully indemnified with regard thereto.

7.2 Procedure for taking possession- The Promoter, upon obtaining the occupancy certificate from the competent authority shall offer in writing the possession of the [Apartment], to the Allottee(s) in terms of this Agreement to be taken within 2 (two) months from the date of issue of such notice and the Promoter shall give possession of the Said Apartment to the Allottee subject to payment of all amount due and payable under this Agreement and Registration of the Deed of Conveyance. The Promoter agrees and undertakes to indemnify the Allottee(s) in case of failure of fulfilment of any of the provisions, formalities, documentation on part of the Promoter.

The Allottee(s), after taking possession, agree(s) to pay the maintenance charges as determined by the Promoter/ Association of Allottees, as the case may be, after the issuance of completion certificate for the Project. The Promoter shall handover the occupancy certificate of the Apartment, as the case may be, to the Allottee at the time of conveyance of the same.

7.3. Failure of Allottee to take possession of [Apartment]- Upon receiving a written intimation from the Promoter as per Para 7.2 above, the Allottee(s) shall take possession of the [Apartment] from the Promoter by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement and the Promoter shall give possession of the [Apartment] to the Allottee(s). In case the Allottee(s) fails to take possession within the time provided as per Para 7.2 above, such Allottee shall continue to be liable to pay maintenance charges as applicable in terms of the rules framed on payment of maintenance charges for the project.

7.4. Possession by the Allottee- After obtaining the occupancy certificate* and handing over physical possession of the [Apartment] to the Allottee, it shall be the responsibility of the Promoter to handover the necessary documents and plan, including common areas to the Association of allottees or the competent authority, as the case may be, as per the local laws:

7.5. Cancellation by Allottee- The Allottee(s) shall have the right to cancel/withdraw his allotment in the Project as provided in the Act:

Provided that where the Allottee(s) proposes to cancel/withdraw from the Project without any fault of the Promoter, the Promoter herein is entitled to forfeit the Booking amount paid for the allotment. The balance amount of money paid by the Allottee(s) shall be returned by the Promoter to the Allottee(s) within forty-five days of such cancellation. The Allottee shall bear the registration charges and stamp duty and incidental charges for registering any Deed of Cancellation.

7.6. Compensation – The Promoter shall compensate the Allottee in case of any loss, caused to him due to defective title of the land, on which the Project is being developed or has been developed, in the manner as provided under the Act and the claim for the interest and compensation under this provision shall not be barred by limitation provided under any law for the time being in force.

Except for occurrence of a Force Majeure event, if the Promoter fails to complete or is unable to give possession of the said [Apartment] (i) in accordance with the terms of this Agreement, duly completed by the date specified in Para 7.1 above; or (ii) due to discontinuance of his business as a developer on account of suspension or revocation of the registration under the provisions of the Act; or for any other reason; the Promoter shall be liable, on demand to the Allottee, in case the Allottee wishes to withdraw from the Project, without prejudice to any other remedy available, to return the total amount received by him in respect of the [Apartment], with interest including compensation in the manner as provided under the Act within forty-five days of it becoming due:

Provided that where if the Allottee does not intent to withdraw from the Project the Promoter shall pay the Allottee interest for every month of delay, till the handing over of the possession of the [Apartment], which shall be paid by the Promoter to the Allottee within forty-five days of it becoming due.

8. **REPRESENTATIONS AND WARRANTIES OF THE PROMOTER:**

The Promoter hereby represents and warrants to the Allottee(s) as follows:

- (i) The Owners have absolute, clear and marketable title with respect to the said Land and the requisite rights to carry out development upon the said Land and absolute, actual, physical and legal possession of the said Land for the Project.
- (ii) The Promoter has lawful rights and requisite approvals from the competent authorities to carry out development of the Project;

- (iii) There are no encumbrances upon the said Land or the Project;
- (iv) There are no litigations pending before any Court of law or Authority with respect to the said Land, Project or the [Apartment];
- (v) All approvals, licenses and permits issued by the competent authorities with respect to the Project, said Land and [Apartment] are valid and subsisting and have been obtained by following due process of law. Further, the Promoter has been and shall, at all times, remain to be in compliance with all applicable laws in relation to the Project, said Land, Building and [Apartment] and common areas till the date of handing over of the Real Estate Project to the association of allottees;
- (vi) The Promoter has the right to enter into this Agreement and has not committed or omitted to perform any act or thing, whereby the right, title and interest of the Allottee(s) created herein, may prejudicially be affected;
- (vii) The Promoter has not entered into any agreement for sale and/or any other agreement / arrangement with any person or party with respect to the Said Apartment which will, in any manner, affect the rights of Allottee under this Agreement;
- (viii) The Promoter confirms that the Promoter is not restricted in any manner whatsoever from selling the said [Apartment] to the Allottee(s) in the manner contemplated in this Agreement;
- (ix) At the time of execution of the conveyance deed the Promoter shall handover lawful, vacant, peaceful, physical possession of the [Apartment] to the Allottee(s) and the common areas to the association of allottees or the competent authority, as the case may be;
- (x) The Schedule Property is not the subject matters of any HUF and that no part thereof is owned by any minor and /or no minor has any right, title and claim over the Schedule Property;
- (xi) The Promoter has duly paid and shall continue to pay and discharge all governmental dues, rates, charges and taxes and other monies, levies, impositions, premiums, damages and/or penalties and other outgoings, whatsoever, payable with respect to the said Project to the competent authorities till the completion certificate has been issued and irrespective of possession of the Apartment along with common areas (equipped with all the specifications, amenities and facilities) has been handed over to the Allottee and the Association of allottees or not;
- (xii) No notice from the Government or any other local body or authority or any legislative enactment, government order, notification (including any notice for

acquisition or requisition of the said property) has been received by or served upon the Promoter in respect of the said Land and/or the Project.

- (xiii) That the project is not Waqf property.

9. EVENTS OF DEFAULTS AND CONSEQUENCES:

9.1 Subject to the Force Majeure clause, the Promoter shall be considered under a condition of default, in the following events:-

- a. The Promoter fails to provide ready to move in possession of the [Apartment / Flat] to the Allottee(s) within the time period specified in Para 7.1 above in this Agreement or fails to complete the Project within the stipulated time disclosed at the time of registration of the Project with the Authority. For the purpose of this Para, 'ready to move in possession' shall mean that the Apartment shall be in a habitable condition which is complete in all respects including the provision of all specifications, amenities and facilities, as agreed to between the parties, and for which occupation certificate and completion certificate, as the case may be, has been issued by the competent authority;
- b. Discontinuance of the Promoter's business as a developer on account of suspension or revocation of his registration under the provisions of the Act or the rules or regulations made thereunder.

9.2. In case of default by the Promoter under the conditions listed above, Allottee(s) is entitled to the following:-

- (i) Stop making further payments to the Promoter as demanded by the Promoter. If the Allottee(s) stops making payments, the Promoter shall correct the situation by completing the construction milestones and only thereafter the Allottee(s) be required to make the next payment without any interest; or
- (ii) The Allottee(s) shall have the option of terminating the Agreement in which case the Promoter shall be liable to refund the entire money paid by the Allottee(s) under any head whatsoever towards the purchase of the Apartment, within forty-five days of receiving the termination notice:

Provided that where an Allottee(s) does not intend to withdraw from the Project or terminate the Agreement, he shall be paid, by the Promoter, interest at the rate prescribed in the Rules, for every month of delay till the handing over of the possession of the [Apartment], which shall be paid by the Promoter to the Allottee within forty-five days of it becoming due.

9.3. The Allottee(s) shall be considered under a condition of default, on the occurrence of the following events:

- (i) In case the Allottee(s) fails to make payments for two consecutive demands made by the Promoter as per the payment plan annexed hereto, despite having been

issued notice in that regard, the Allottee(s) shall be liable to pay interest to the Promoter on the unpaid amount at the rate prescribed in the Rules.

- (ii) In case of default by Allottee under the conditions listed above continues for a period beyond two consecutive months after notice from the Promoter in this regard, the Promoter, may cancel the allotment of the [Apartment] in favour of the Allottee(s) and refund the money paid to him by the Allottee(s) by deducting the booking amount and the interest liabilities and this Agreement shall thereupon stand terminated. Further, upon the termination of this Agreement in the aforesaid circumstances, the Allottee shall have no claim of any nature whatsoever on the Promoter and/or the Said Apartment and Appurtenances and the Promoter shall be entitled to deal with and/or dispose off the Said Apartment and Appurtenances in the manner it deems fit and proper.

Provided that the Promoter shall intimate the Allottee about such termination at least thirty days prior to such termination. **CONVEYANCE OF THE SAID APARTMENT:**

10. CONVEYANCE OF THE SAID APARTMENT:

The Promoter, on receipt of Total Price of the [Apartment] and Appurtenance from the Allottee shall execute a conveyance deed drafted by the Promoter's Legal Advisor and convey the title of the [Apartment] together with proportionate indivisible share in common areas within three months from the date of issuance of the occupancy certificate and the completion certificate, as the case may be, to the Allottee:

However, in case the Allottee(s) fails to deposit the stamp duty, registration charges within the period mentioned in the demand notice, letter, the Allottee(s) authorizes the Promoter to withhold registration of the conveyance deed in his/her favour till payment of stamp duty and registration charges to the Promoter is made by the Allottee(s). The Allottee shall be solely responsible and liable for compliance of the provisions of Indian Stamp Act, 1899 including any actions taken or deficiencies/ penalties imposed by the competent authority(ies).

11. **MAINTENANCE OF THE SAID BUILDING/ APARTMENT/ PROJECT :** The Promoter shall be responsible for providing and maintaining the essential services in the Project, till the taking over of the maintenance of the Project by the Association of allottees upon the issuance of the completion certificate of the Project. The cost of such maintenance will be borne by the Allottee, payable to the Promoter from the date of obtaining the possession letter until the handover of maintenance of the Project to the Affiliated Company and thereafter to the association of Allottees. Maintenance Expenses, as referred to in this Agreement, shall include all expenses for the maintenance, management, upkeep, and administration of the Common Areas and Installations, as well as the provision of common services to the Allottee (mentioned in the Schedule E and F below).

Additionally, it encompasses all other expenses for common purposes, to be contributed, borne, paid, and shared by the Allottees of the Project.

Provided that the Proportionate Share of all common expenses mentioned in Schedule F, as applicable, shall be payable to the Maintenance Account from time to time. Without any default and prejudice, the Allottee shall pay the Maintenance Charge, a minimum of the Maintenance Charges as expressly provided in this Agreement, based on the Super Built-up area of the Allottee's respective unit. This minimum rate shall be subject to revision from time to time as deemed fit and proper by the Maintenance Management at its sole and absolute discretion, considering the general escalation in market rates for such services.

Provided that the proportionate share of maintenance charges for the unsold units within the promoter's allocation shall not be contributed by the promoter.

12. **DEFECT LIABILITY :**

12.1. It is agreed that in case any structural defect or any other defect in workmanship, quality or provision of services or any other obligations of the Promoter as per this Agreement relating to such development is brought to the notice of the Promoter within a period of five years by the allottee from the date of handing over possession, it shall be the duty of the Promoter to rectify such defects without further charge, within thirty days, and in the event of Promoter's failure to rectify such defects within such time, the aggrieved Allottee(s) shall be entitled to receive appropriate compensation in the manner as provided under the Act.

13. **RIGHT OF ALLOTTEE TO USE COMMON AREAS AND FACILITIES SUBJECT TO PAYMENT OF TOTAL MAINTENANCE CHARGES:**

The Allottee hereby agree to purchase the Said Apartment on the specific understanding that is/her right to the use of Common Areas/Whole Project Included Amenities shall be subject to timely payment of total maintenance charges, as determined by the Promoter (until formation of the association of Allottee) and thereafter billed by the maintenance agency appointed or the association of Allottee (or the maintenance agency appointed by it) and performance by the Allottee of all his/her obligations in respect of the terms and conditions specified by the maintenance agency or the association of Allottee from time to time.

14. **RIGHT TO ENTER THE APARTMENT FOR REPAIRS:**

The Promoter/ maintenance agency/Association of allottees shall have rights of unrestricted access of all common areas, garages/covered parking and parking spaces of the Project for providing necessary maintenance services and the Allottee(s) agrees to permit the Association of allottees and/or maintenance agency to enter into the [Apartment] or any part thereof, after due notice and

during the normal working hours, unless the circumstances warrant otherwise, with a view to set right any defect.

15. **USAGE:**

Use of Basement(s) and service areas:- The basement and service areas, if any, as located within the AJMIR _____, shall be earmarked for purposes such as parking spaces and services including but not limited to transformer, underground water tanks, pump rooms, maintenance and service rooms, fire fighting pumps and equipment's etc. and other permitted uses as per sanctioned plans. The Allottee(s) shall not be permitted to use the services areas and the easements in any manner whatsoever, other than those earmarked as parking spaces, and the same shall be reserved for used by the Association of allottees for rendering maintenance services.

16. **GENERAL COMPLIANCE WITH RESPECT TO THE APARTMENT :**

16.1. Subject to Para 12 above, the Allottee(s) shall, after taking possession, be solely responsible to maintain the said [Apartment] at his/her own cost, in good repair and condition and shall not do or suffer to be done anything in or to the said building [Apartment], or the staircases, lifts, common passages, corridors, circulation areas, atrium or compound which may be in violation of any laws or rules of any authority or change or alter or make additions to the said Apartment, and keep the said Apartment,, its walls and partitions, sewers, drains, pipes and appurtenances thereto or belonging thereto in good and tenantable repair and maintain the same in a fit and proper condition and ensure that the support, shelter etc. of the building is not in any way damaged or jeopardized.

16.2. The Allottee further undertakes, assures and grantees that he/ she would not put any sign-board/ name-plate, neon light, publicity material or advertisement material etc. on the façade of the building or anywhere on the exterior of the Project, building therein or common areas. The Allottee also not change the color scheme of outer wall or painting of the exterior side of windows or carry out any change in the exterior elevation or design. Further the Allottee shall store any hazardous or combustible goods in the [Apartment] or place any heavy material in the common passages or staircase of the building. The Allottee shall also not remove any wall, including the outer and load wall of the [Apartment].

16.3. The Allottee shall plan and distribute its electric load in conformity with the electric systems installed by the Promoter and thereafter the Association of allottees and/or maintenance agency appointed by the association of allottees. The Allottee shall be responsive for any loss or damages arising out of breach of any of the aforesaid conditions.

17. **COMPLIANCE OF LAWS, NOTIFICATIONS ETC. BY PARTIES:**

The Parties are entering into this Agreement for the allotment of a [Apartment] with the full knowledge of all laws, rules, regulations, notifications applicable to the Project. That the Allottee hereby undertakes that he/she shall comply with and carry out, from time to time after he/she has taken over for occupation and use the said Apartment, all the requirements, requisitions, demands and repairs which are required by any competent Authority in respect of the Apartment at his/ her own cost.

18. **ADDITIONAL CONSTRUCTIONS:**

The Promoter undertakes that it has no right to make additions or to put up additional structure anywhere in the Project after the building plan, layout plans sanction plan and specifications, amenities and facilities has been approved by the competent authorities and disclosed, except for as provided in the Act and save as expressly provided in this Agreement.

19. **PROMOTER SHALL NOT MORTGAGE OR CREATE A CHARGE:**

After the Promoter executes this Agreement he shall not mortgage or create a charge on the said [Apartment] and if any such mortgage or charge is made or created then notwithstanding anything contained in any other law for the time being in force, such mortgage or charge shall not affect the right and interest of the Allottee(s) who has taken or agreed to take such [Apartment/ Building].

20. **APARTMENT OWNERSHIP ACT (OR THE RELEVANT STATE ACT):**

The Promoter has assured the Allottee that the project in its entirety is in accordance with the provisions of the West Bengal Apartment Ownership Act, 1972, The Promoter showing compliance of various laws/ regulations as applicable in said Act.

21. **BINDING EFFECT :**

Forwarding this Agreement to the Allottee(s) by the Promoter does not create a binding obligation on the part of the Promoter or the Allottee(s) until, firstly, the Allottee(s) signs and delivers this Agreement with all the Schedules along with the payments due as stipulated in this payment plan within thirty days from the date of receipt by the Allottee(s) and secondly, appears for registration of the same before the concerned Sub-Registrar as and when intimated by the Promoter. If the Allottee(s) fails to execute and deliver to the Promoter this Agreement within 30 (thirty) days from the date of its receipt by the Allottee(s) and/or appear before the Sub-Registrar for its registration as and when intimated by the Promoter, then the Promoter shall serve a notice to the Allottee(s) for rectifying the default, which if not rectified within 30 (thirty) days from the date of its receipt by the Allottee(s), application of the Allottee shall be treated as cancelled and all sums deposited by the Allottee(s) in connection therewith including the booking amount shall be returned to the Allottee(s) without any interest or compensation whatsoever but after deduction of the processing fees.

22. **ENTIRE AGREEMENT:**

This Agreement, along with its schedules, constitutes the entire Agreement between the Parties with respect to the subject matter hereof and supersedes any and all understandings, any other agreements, allotment letter, correspondences, arrangements whether written or oral, if any, between the Parties in regard to the said Apartment/ Building, as the case may be.

23. **RIGHT TO AMEND :**

This Agreement may only be amended through written consent of the Parties.

24. **PROVISIONS OF THIS AGREEMENT APPLICABLE ALLOTTEE/ SUBSEQUENT ALLOTTEES:**

It is clearly understood and so agreed by and between the Parties hereto that all the provisions contained herein and the obligations arising hereunder in respect of the said [Apartment] and the Project shall equally be applicable to and enforceable against and by any subsequent Allottee of the [Apartment], in case of a transfer, as the said obligations go along with the Apartment for all intents and purposes.

25. **WAIVER NOT A LIMITATION TO ENFORCE:**

The Promoter may, at its sole option and discretion, without prejudice to its rights as said out in this Agreement waive the breach by the Allottee in not making payments as per the payment plan [Annexure C] including waving the payment of interest for delayed payment. It is made clear and so agreed by the Allottee that exercise of discretion by the Promoter in the case of one allottee shall not be construed to be a precedent and /or binding on the Promoter to exercise such discretion in the case of other allottees.

Failure on part of the Parties to enforce at any time or for any period of time the provisions hereof shall not be construed to be a waiver of any provisions or of the right thereafter to enforce each and every provision.

26. **SEVERABILITY:**

If any provision of this Agreement shall be determined to be void or unenforceable under the Act or the Rules and Regulations made thereunder or under other applicable laws, such provisions of the Agreement shall be deemed amended or deleted in so far as reasonably inconsistent with the purpose of this Agreement and to the extent necessary to conform to the Act or the Rules and Regulations made thereunder or the applicable law, as the case may be, and remaining provisions of this Agreement shall remain valid and enforceable as applicable at the time of execution of this Agreement.

27. **METHOD OF CALCULATION OF PROPORTIONATE SHARE WHEREVER REFERRED TO IN THE AGREEMENT:**

Wherever in this Agreement it is stipulated that the Allottee(s) has to make any payment, in common with other allottee(s) in the Project, the same shall be the proportion which the carpet area of the [Apartment] bears to the total carpet area of all the [Apartments] in the Project.

28. **FURTHER ASSURANCES:**

Both Parties agree that they shall execute, acknowledge and deliver to the other such instruments and take such other actions, in additions to the instruments and actions specifically provided for herein, as may be reasonably required in order to effectuate the provisions of this Agreement or of any transaction contemplated herein or to confirm or perfect any right to be created or transferred hereunder or pursuant to any such transaction.

29. **PLACE OF EXECUTION:**

The execution of this Agreement shall be completed only upon its execution by the Promoter through its authorized signatory at the Promoter's Office, or at some other place, which may be mutually agreed between the Promoter and the Allottee, after the Agreement is duly executed by the Allottee and the Promoter or simultaneously with the execution the said Agreement shall be registered at the office of the District Sub-Registrar, Alipore or Additional District Sub-Registrar at Sealdah or Registrar of Assurances at Kolkata Hence this Agreement shall be deemed to have been executed at the office of the Promoter.

29. **NOTICES:**

That all the notices to be served on the Allottee and the Promoter as contemplated by this Agreement shall be deemed to have been duly served if sent to the Allottee or the Promoter by registered post at their respective addresses specified below:-

It shall be the duty of the Allottee and promoter to inform each other of any changes subsequent to the execution of this Agreement in the above address by registered post failing which all communications and letters posted at the above address shall be deemed to have been received by the Promoter or the Allottee, as the case may be.

31. **JOINT ALLOTTEE:**

That in case there are Joint Allottees all communications shall be sent by the Promoter to the Allottee whose name appears first and at the address given by him/her which shall for all intents and purposes to consider as properly served on all the Allottee(s).

32. **GOVERNING LAW:**

That the rights and obligations of the parties under or arising out of this Agreement shall be construed and enforced in accordance with the Act and the Rules and Regulations made thereunder including other applicable laws of India for the time being in force.

33. **DISPUTE RESOLUTION:**

All or any dispute arising out or touching upon or in relation to the terms and conditions of this Agreement, including the interpretation and validity of the terms thereof and the respective rights and obligations of the Parties, shall be settled amicably by mutual discussions, failing which the same shall be settled under Arbitration and Conciliation Act 1996.

[Please insert any other terms and conditions as per the contractual understanding between the parties, however, please ensure that such additional terms and conditions are not in derogation of or inconsistent with the terms and conditions set out above or the Act and the Rules and Regulations made thereunder.]

34. **SAVINGS:**

Any application letter, allotment letter, agreement, or any other document signed by the allottee, in respect of the apartment, plot or building, as the case may be, prior to the execution and registration of this agreement for sale for such apartment, plot or building, as the case may be, shall not be construed to limit the rights and interests of the allottee under the agreement for sale or under the Act the rules or the regulations made thereunder.

35. TO BE READ WITH POINT NO 1

- a) To the allottee and the Project to the association of allottees or the competent authority, as the case may be, after obtaining the completion certificate;
- b) Provided that if there is any new imposition or increase of any development charges after the expiry of the scheduled date of completion of the project as per registration with the Authority, which shall include the extension of registration, if any, granted to the said project by the Authority, as per the Act, the same shall not be charged from the Allottee.
- c) The Promoter shall periodically intimate to the Allottee(s), the amount payable as stated in Schedule C below and the Allottee(s) shall make payment demanded by the Promoter within 30 days from the date of such written intimation. In addition, the Promoter shall provide to the Allottee (s) the details of the taxes paid or demanded along with the Acts/rules/notifications together with dates from which such taxes/levies etc. have been imposed or become effective;
- d) The Total price of Apartment/Unit includes (1) pro rata share in the common areas; and (2) NIL covered car park(s)/right to park car in the Mechanical car parking, if any and other properties and appurtenances as provided in the Agreement.
- e) **TDS:** if applicable, the tax deduction at source (TDS) on the Income Tax laws shall be deducted by the Allotees on the consideration payable to the promoter And the same shall be deposited by Allotees To the concerned authority within the time period stipulated under the law and the Allotees shall provide proper evidence thereof to the promoter within 60 days of such deduction. If such deposit of TDS is not made by the Allotees to the concerned authority or proper evidence thereof is not provided to the Promoter, then the same shall be treated as default on the part of the Allotees under this Agreement and the amount they are shall be treated as outstanding.
- f) The Total Price of Apartment includes recovery of price of land, construction of, not only the Apartment but also, the common areas, internal development charges, external development charges, taxes, cost of providing electric wiring, electrical connectivity to the Apartment, lift, water line and plumbing, finishing with paint, marbles, tiles, doors, windows and firefighting equipment in the common areas, maintenance charges etc. and includes cost

for providing all other facilities, amenities and specification to be provided within the Apartment and the Project.

- g) The Promoter may allow, in its sole discretion, a rebate for early payments of instalments payable by the Allottee(s) by discounting such early payments @ 0.5% per annum for the period by which the respective instalment has been preponed. The provision for allowing rebate and such rate of rebate shall not be subject to any revision/withdrawal, once granted to an Allottee(s) by the Promoter.
- h) The promoter retains the right to alter, modify, or amend the existing sanctioned buildings, including the construction of additional floors or lateral expansions of the project. The Allottee acknowledges and consents to these potential changes and agrees not to raise any objections. The promoter assures that the building's foundation has been planned to accommodate the load of additional floors. Furthermore, the promoter intends to convert or change the use of the building to commercial, mercantile, or non- residential purposes. Since this will not affect the residential portion or the said premises, the Allottee consents to this change and agrees not to raise any objections.
- i) The Allottee has the right to visit the Project site to assess the extent of development of the Project and his Apartment, as the case may be.

36. TO BE READ WITH POINT NO.2

- a) In the event of the Allottee obtaining any financial assistance and/or housing loan from any bank/ financial institution, in no event the Promoter shall assume any liability and/or responsibility for any loan and/or financial assistance which may be obtained by the Allottee from such bank/ financial institution.
- b) The timely payment of all the amounts payable by the Allottee under this Agreement (including the Total Price), is the essence of the contract. An intimation forwarded by the Promoter to the Allottee that a particular milestone of construction has been achieved shall be sufficient proof thereof.
- c) In the event of delay and/or default on the part of the Allottee in making payment of any GST, Service Tax, VAT, TDS or any other tax, levies, cess etc., then without prejudice to any other rights or remedies available to the Promoter under this Agreement or under applicable law, the Promoter shall be entitled to adjust against any subsequent amounts received from the Allottee, the said unpaid tax levy, cess etc. along with interest, penalty etc. payable thereon, from the due date till the date of adjustment.

37. TO BE READ WITH POINT NO 10:

- a) Further the Allottee shall be bound by its obligations as morefully mentioned in Clause 7.3 of this Agreement.

38. TO BE READ WITH POINT NO 12:

- a) It is clarified that the Promoter shall not be liable for any such defects if the same have been caused by reason of the default and/or negligence of the Allottee and/or any other Allottee in the Project or acts of third party(ies) or on account of any force majeure events including on account of any repairs / redecoration / any other work undertaken by the Allottee and/or any other allottee/person in the Project. The Allottee are aware that the Said Building is a monolithic structure and any change(s), alteration(s) including breaking of walls or any structural members or the construction of any new wall or structural member may adversely impact the Said Building at various places or in its entirety and hence any change(s) or alteration(s) as mentioned hereinabove will result in immediate ceasing of the Promoter's obligation to rectify any defect(s) or compensate for the same as mentioned in this Clause and the Allottee and/or the association of Allottee shall have no claim(s) of whatsoever nature against the Promoter in this regard.

39. ADDITIONAL TERMS AND CONDITIONS:

The parties have agreed that notwithstanding anything to the contrary contained in this Agreement hereinbefore, the Agreement shall be subject to the following other terms conditions and covenants on the part of the Owners, Promoter and Allottee to be respectively paid observed and performed, as the case may be (it being clarified that in the event of any inconsistency or contradictions in the clauses abovementioned and those contained hereinafter, the provisions of the clauses contained in this clause 35 hereinafter contained shall prevail).

The additional terms and conditions as per the contractual understanding between the Parties are recorded hereunder. However, it is expressly clarified that such additional terms and conditions are not in derogation of or inconsistent with the terms and conditions set out above or the Act.

- 39.1. The Allottee prior to execution of the Deed of Sale, if intends to nominate his/her/their provisionally allotted apartment unto and in favour of any other person or persons in his/her/their place and stead, the Allottee may do so with the permission of the Promoter subject to payment of administrative charges to the Promoter @ 2% (two per cent) of the total transfer price or purchase price of Unit whichever is higher together with applicable GST.
- 39.2. The Allottee agrees and understands that all the standard fitting, interiors, furniture, kitchenette and fixtures and dimension provided in the show/model residential Apartment exhibited at the site only provides a representative idea and the actual Apartment agreed to be constructed will be

as per specifications mentioned in this agreement in Schedule-D and the same may not include the fittings and fixtures of the model Apartment and even if such fittings and fixtures are provided they may vary as to make, colour, shade, shape and appearance from the ones provided in the model Apartment and the Allottee shall not be entitled to raise any claim for such variation.

- 39.3. Notwithstanding anything contained herein, by the execution of this Agreement the Allottee has/have provided and hereby and hereunder confirm(s) his/her/its/their consent to the Promoter to/for the creation of any mortgage, security, charge or other encumbrances over and in respect of the Said Land and/or the Building and/or any part or portion thereof in favour of any bank and/or financial institution providing loan and/or financial assistance to the Promoter for the purpose of development of the Project provided that no such mortgage, security, charge or other encumbrances shall in any manner affect the right, title and interest of the Allottee. For the avoidance of any doubt it is clarified that this Agreement by itself shall be treated as the written consent of the Allottee for creation of charge/ mortgage over any part or portion of the Said Land and/or the Building, and no separate consent of the Allottee shall be required for the said purpose.
- 39.4. In the event of the Allottee obtaining any financial assistance and/or housing loan from any bank/ financial institution the Promoter shall act in accordance with the instructions of the bank/ financial institution in terms of the agreement between the Allottee and the Bank/ financial institution, SUBJECT HOWEVER the Promoter being assured of all amounts being receivable for sale and transfer of the Apartment and in no event the Promoter shall assume any liability and/or responsibility for any loan and/or financial assistance which may be obtained by the Allottee from such bank/ Financial Institution.
- 39.5. In the event of any change in the specifications necessitated on account of any Force Majeure events or to improve or protect the quality of construction, the Promoter, on the recommendations of the Architect, shall be entitled to effect such changes in the materials and specifications provided the Promoter shall ensure that the cost and quality of the substituted materials or specifications is equivalent or higher than the quality and cost of materials of specifications mentioned in the Schedule D.
- 39.6. The Promoter reserves the right to change the name of the building in which the Apartment is located at any time prior to the execution of the Deed of Sale, at its sole discretion.
- 39.7. The Allottee hereby agrees and acknowledges that the Promoter shall be entitled to appoint a Property Management Company/Agency to carry out the management and maintenance of the Project and the Allottee shall be bound by the terms and conditions of such appointment.
- 39.8. The Allottee hereby agrees to abide by and observe all the rules, regulations, restrictions, terms and conditions as may be framed and/or imposed by the Promoter/Association of Allottees/Facility Management Company from time to time for the common benefit, occupation, use and enjoyment of the Project.
- 39.9. The Allottee shall not use the Apartment or permit the same or any part thereof to be used for any purpose other than for residential purpose only.

- 39.10. The Allottee shall not carry on or permit to be carried on any activity or business whatsoever which in the opinion of the Promoter/Association of Allottees is or is likely to be a nuisance or annoyance to the other residents of the Project.
- 39.11. The Allottee shall not do or permit to be done any act or thing which may render void or voidable any insurance policy in respect of the Project or any part thereof.
- 39.12. The Allottee shall not store or keep any hazardous, inflammable or combustible goods/materials in the Apartment or the Common Areas.
- 39.13. The Allottee shall not make any structural addition/alteration in/to the Apartment or the Common Areas without the prior written permission of the Promoter/Association of Allottees.
- 39.14. The Allottee shall not do or permit to be done any act which may cause damage to the structural integrity of the building or any part thereof.
- 39.15. The Allottee shall not place or cause to be placed any article or object in the Common Areas including verandahs, windows, balconies etc. which may fall down or cause damage or injury to any person or property.
- 39.16. The Allottee shall not keep any dead stock or other articles in the corridors, verandahs, staircases or passages or on the terrace.
- 39.17. The Allottee shall not use or permit to be used any portion of the Apartment or Common Areas for political activity or any public or noisy activities which may cause inconvenience to the other residents.
- 39.18. The Allottee shall not object to the Promoter/Association of Allottees/Facility Management Company installing/maintaining any dish antenna/CCTV cameras/mobile tower or other equipment on the roof of the building or any other Common Areas of Building.
- 39.19. The Allottee shall not install any dish antenna or other equipment in the Common Areas or on the external walls/facade of the building without prior permission.
- 39.20. The Allottee shall not do or permit anything to be done which may cause damage to the reputation or goodwill of the Project.
- 39.21. The Allottee hereby agrees and confirms that he/she/it shall at all times during the period of his/her/its ownership of the Apartment abide by and perform all the terms, conditions and covenants of this Agreement and also the rules, regulations, restrictions, terms and conditions as may be framed and/or imposed by the Promoter/Association of Allottees/Facility Management Company from time to time for the common benefit, occupation, use and enjoyment of the Project.
- On and from the date of possession of the Said Apartment in the project “**AJMIR IRIS**”, the Allottee shall:

(a) Project Management and Compliance

- Cooperate in the management and maintenance of the project “**AJMIR IRIS**”.
- Observe, comply with, and abide by all rules framed from time to time by the Promoter (until formation of the Association) or thereafter by

the Association, for the beneficial common use and enjoyment of the common areas, amenities, and facilities in the project.

(b) Maintenance Charges and Consequences of Default

- Pay and bear the proportionate share of common expenses (including GST) incurred by the Promoter until formation of the Association.
- Regularly and punctually pay all Maintenance Charges without any abatement or deduction.
- In case of default:
 - i. Pay interest at 2% per month on overdue amounts.
 - ii. If default continues for three months, forfeit access to all facilities, amenities, and utilities in the project. The Promoter/Association may then:
 - Discontinue electricity supply to the Said Apartment.
 - Disconnect water supply.
 - Restrict use of lifts by the Allottee, family members, domestic help, and visitors.
 - Discontinue DG power back-up.
 - Suspend access to all amenities and facilities for the Allottee, family members, and guests.
 - Exercise a lien on the Said Apartment for unpaid Maintenance Charges.
- Services and facilities shall not be restored until the Allottee pays all dues, accrued interest, and recovery costs/charges/expenses incurred by the Promoter/Association.
- Pay monthly Maintenance Charges (if applicable) and Annual Maintenance Contract (AMC) charges for any allotted mechanical car parking space.

(c) Permitted Uses

- Use the Said Apartment strictly for residential purposes only.
- Use allocated car parking space(s) solely for parking the Allottee's own car(s)/two- or four-wheeler(s). Not let out, part with possession, encumber, or use it for any other purpose (except as a whole with the Said Apartment to another apartment owner, with an undertaking for parking use only). Cooperate for ingress/egress if interdependent with other spaces.
- Use paths, passages, staircases, and the Multipurpose Hall solely for ingress/egress or permitted purposes (e.g., small family functions, owners' meetings; warming pre-cooked food only—no full cooking, weddings, fire-lighting, animal sacrifice, or loudspeakers beyond limits). Pay charges for exclusive use/electricity as fixed by Promoter/Association. Outdoor festivals allowed only in designated areas until 10 p.m., within tolerable noise limits.

(d) Prohibitions

- Not subdivide the Said Apartment or car parking space.
- Not make additions/alterations to the building structure (internal/external), window/balcony grills, balcony colors, verandas, lounges, balconies, lobbies, elevation, or external walls/doors/windows (must match Promoter/Association-approved scheme). Not change the project name.
- Not park vehicles without allotted space; not store dangerous/offensive/combustible/explosive items; not slaughter animals/birds or injure others' sentiments.
- Not cause nuisance, annoyance, damage, or injury to common areas, other apartments, or adjoining properties (e.g., no dust/rubbish in common areas except designated spots; no articles/objects placed therein; no withdrawing support).
- Not allow watchmen/drivers/domestic servants to sleep/squat in common passages/lobbies/terraces/corridors/lift rooms/gardens. Not keep/harbor birds/animals/pets in common areas (pets allowed in elevators/common areas only if accompanied).
- Not use the Said Apartment (or permit use) for non-residential, illegal, immoral, commercial, or industrial purposes (e.g., no boarding house, club, nursing home, etc.); not block/store in parking spaces.
- Not encumber the Said Apartment except for housing loans from reputed banks/financial institutions to pay consideration under this Agreement (prior to conveyance deed registration).

(e) General Conduct

- Strictly follow Promoter/Association rules on usage/timings of facilities/amenities.
- Ensure all interior works, furniture/fixture installation, repairs, or renewals occur only during daylight hours, without excessive noise causing discomfort to other co-allotees.
