Will of Mr. Ranajit Mohan Bardhan and Mrs. Mamata Bardhan

Will of Mrs. Mamata Bardhan

I declare this document to be my final will and testament, and revoke all earlier wills and testaments by me,

I appoint my husband Mr. Ranajit Mohan Bardhan to be the sole executor of my will. If he predeceases me, I appoint Mrs. Suchita Ghosh, my younger sister, presently residing at B-12 Indrapuri, New Delhi-110012, to be sole executor. In case Mrs. Suchita Ghosh is unable to act, then I appoint Mrs. Shanta Ghosh, my cousin, presently residing at 506 A Keyatala Road, Kolkata-700029 to be the sole executor.

- 2 -

I bequeath my entire estate and property to my husband, Mr. Ranajit Mohari Bardhan. If my husband does not survive me, then I would like my entire estate and property to be distributed as follows:

- a) The house with the address 221 Parmasree Palli, Behala, Kolkata - 700 060:
- (i) The ground floor ownership to be equally shared between my son Dr. Indrajit Bardhan and daughter Mrs. Mahua Guha.
 - (ii) The first floor ownership to be retained by my son Dr. Indrajit Bardhan.
 - (iii) The second floor ownership to be retained by daughter Mrs. Mahua Guha.
 - (iv) The third floor roof ownership to be equally shared between my son and daughter.

In case either of them want to sell off his/her share, the first option to become the buyer, at a reasonable price, will vest upon my son or daughter.

(b) A nominee has been assigned for my money deposits in Savings Accounts and Fixed Deposits in Banks, Fixed Deposits in companies, Bonds, Mutual Funds, and Equity Shares in companies. On my death, the said nominee will take action to recover these 'assets' and the proceeds thereof should be equally shared between my son Dr. Indrajit Bardhan and daughter Mrs. Mahua Guha.

(c) In case my son and/or daughter want to donate any of my possession or proceeds thereof, then such donations have to be restricted to Jadavpur University, Ramkrishna Mission, Bharat Sevashram Sangha, and/or Shri. Aurobindo Ashram (Pondicherry).
