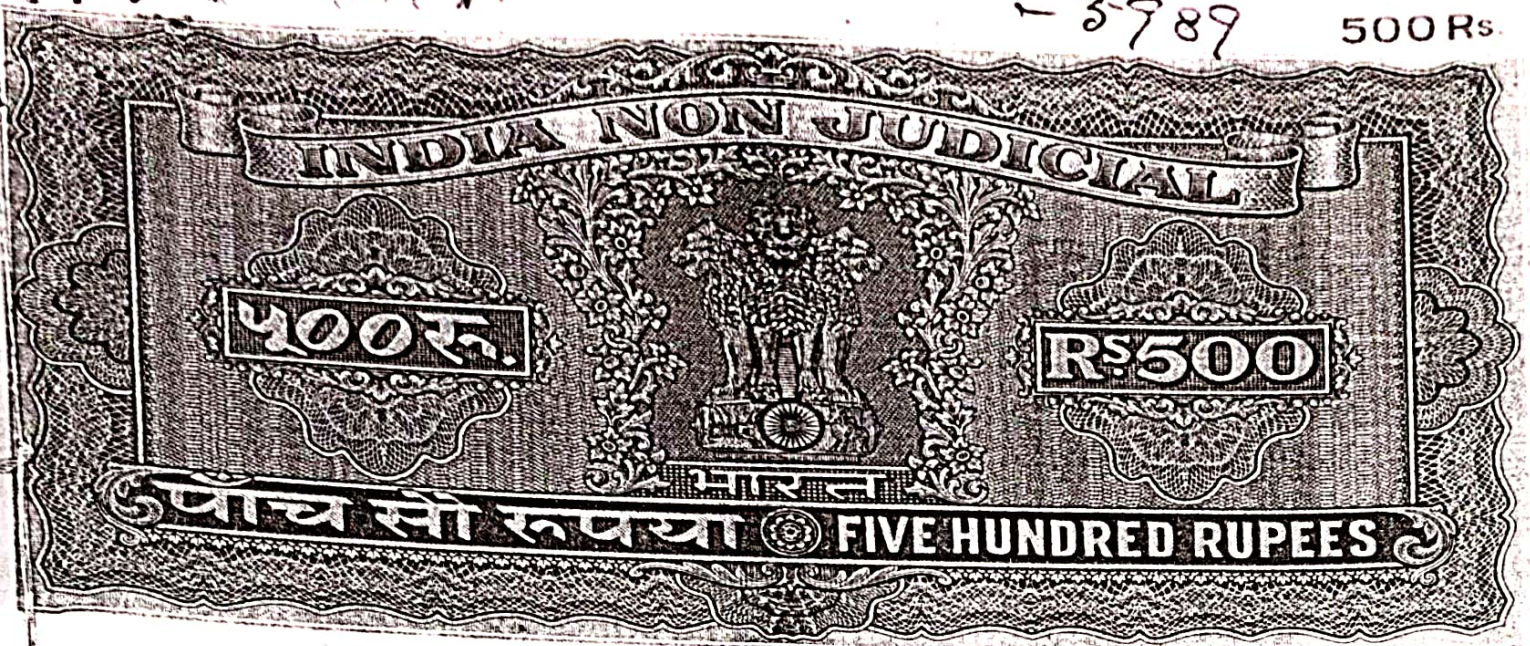

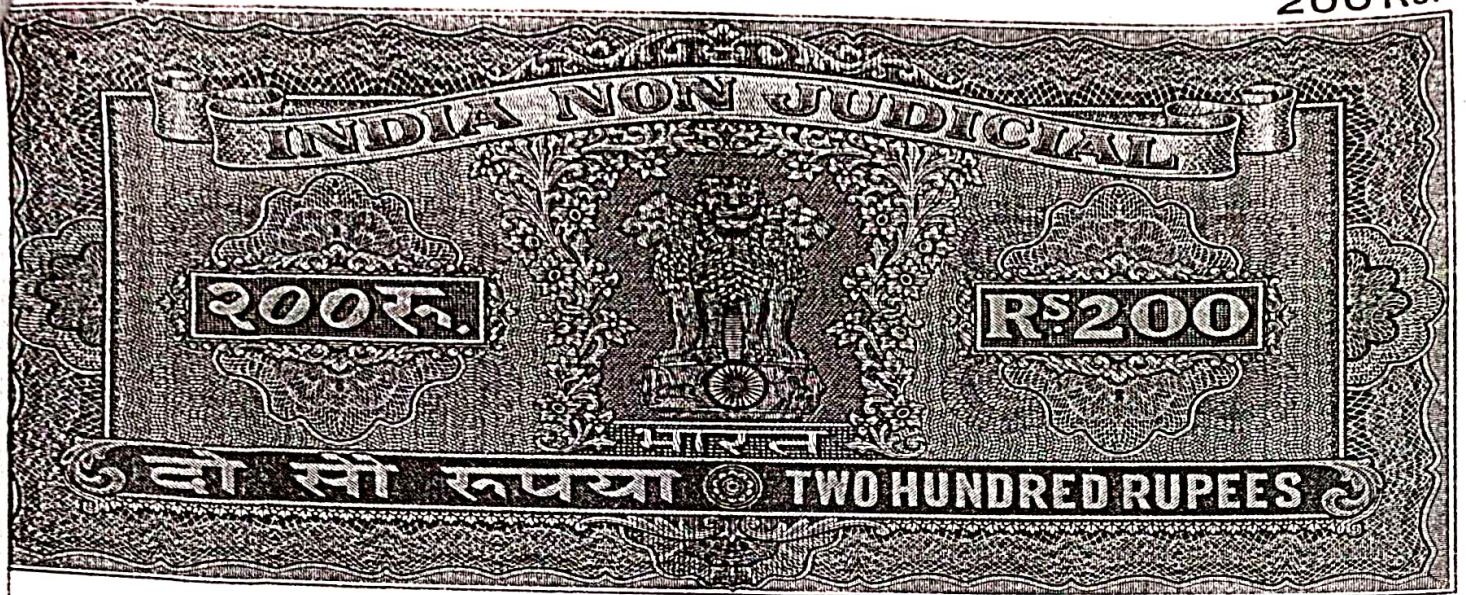

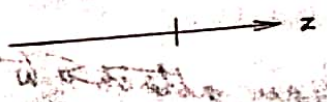

ROAD ALIGNMENT



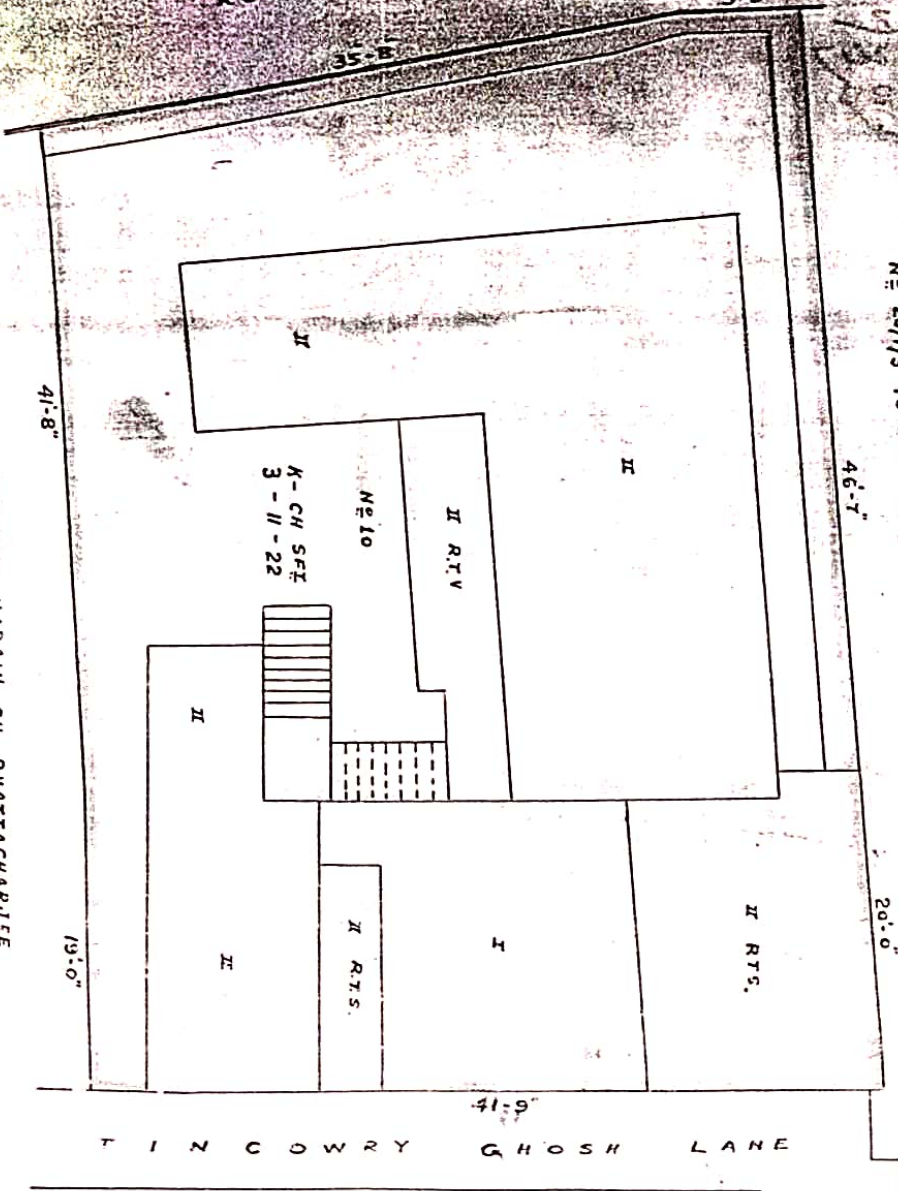
PLAN OF PREMISES, N^o 10 TINCOWRY GHOSH LANE
