No. 138, Touzi No. - 146, Pargana - Anowarpur, comprised in R.S. & L.R. Dag No. 430, 431, 419 R.S. Khatian No. 167, 498, 207, L.R. Khatian No. 4841, 5141, 4635 under A.D.S.R.O.- Barasat, P.S.- Barasat at present Madhyamgram, District - North 24 Parganas under the jurisdiction of Madhyamgram Municipality, Ward No. 19, Holding No. 20, Nandan kanan Main Road, Kolkata-700130, a residential building, does not have any provision of Fire Fighting facility and Emergency Evacuation Facility as the height of the project (**11mtrs**) is below the Height/Elevation limit set out by the West Bengal Fire & Emergency Services, Government of West Bengal. Although we have included a staircase in the project, which may serve as an emergency evacuation facility.
