NOW THIS DEED OF GIFT WITNESSETH that the Donor do hereby and hereunder renounce all his estate and right title and interest in the property which is morefully and particularly described in the Schedule hereunder with intent to vest the same in and grant convey transfer give and assure unto and to the use of the Donce freely and voluntarily and delivered possession of the same unto and in favour of the Donee TO HAVE AND TO HOLD the same for the use and benefit absolutely and unconditionally forever and the Donor grant, convey, transfer, assign and assure unto the Donee free from attachments and other defects in title ALL THAT the property described in the Second Schedule hereto OR HOWSOEVER otherwise the said property now or heretofore were or was situate, butted, bounded, called, known, numbered, described and distinguished TOGETHER WITH the land or ground hereupon or on part whereof the same is erected and built together further with all houses, out-house or other buildings, erections, fixtures, walls, yards, courtyards and benefit and advantages of ancient and other rights, liberties, easements, privileges, appendages and appurtenances whatsoever to the said property or any part thereof belonging or in any wise appertaining to or with the same of any part thereof usually held, used, occupied or enjoyed or reputed to belong or be appurtenant thereto AND the reversion and reversions, remainder and remainders, rents, issues and profits thereof and of every part thereof together furthermore all the estate, right, title, inheritance, use, trust, property, claim and demand whatsoever both at law and in equity of the Donor into and upon the said property or every part thereof AND all deeds, pattas, muniments, writings and evidences of title which in any wise relate to



the said property or any part of parcel thereof and which now are or hereafter shall or may be in the custody, power or possession of the Donor, his heirs, executors, administrators or representatives or any person from whom they can or may procure the same without action or suit at law or in equity TO ENTER INTO AND HAVE HOLD OWN POSSESS AND ENJOY the said property and every part thereof hereby granted, conveyed and transferred or expressed and intended so to be with his rights, members and appurtenances unto and to the use of the Donce his heirs, executors, administrators, representatives and assigns forever freed and discharged from or otherwise by the Donor well and sufficiently indemnified of and against all encumbrances, claims, liens etc. whatsoever created or suffered by the Donor from to these presents AND the Donor do hereby for himself, his heirs, executors, administrators and representatives, covenant with the Donee, his heirs, executors, administrators, representatives and assigns THAT notwithstanding any act, deed, or thing whatsoever, by the Donor or by any of his predecessors and ancestors in title, done or executed or knowingly suffered to the contrary he the Donor had at all material times heretofore and now has good right, full power, absolute authority and indefeasible title to grant, convey, transfer, assign and assure the said property hereby granted, conveyed and transferred or expressed or intended so to be, unto and to the use of the Donee his heirs, executors, administrators, representatives and assigns in the manner aforesaid AND THAT the Donee, his heirs, executors, administrators, representatives and assigns shall and may at all times hereafter peaceably and quietly enter into hold, possess and enjoy the said property and every part
