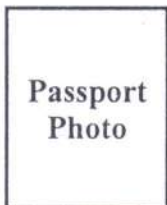

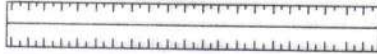

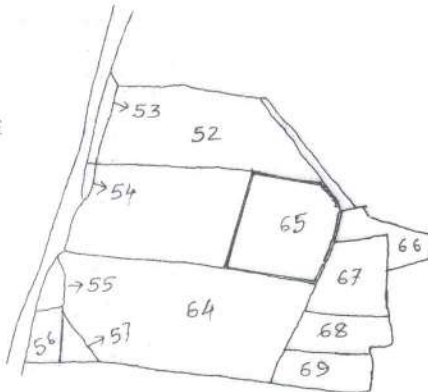
Part Trace Map Of Mouza - GOURCHARAN, J. L. No - 81

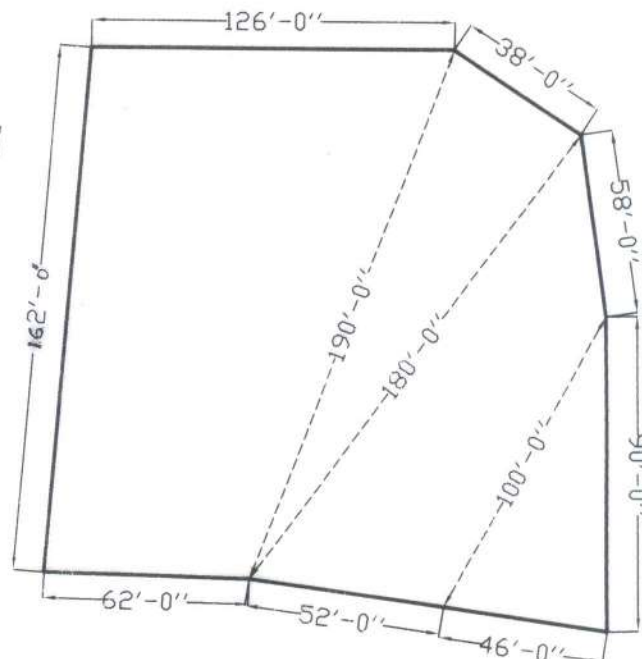
Site Plan Of Proposed Land As Per Possession






