AND whereas a considerable number of such people were compelled by circumstances to use vacant lands in the urban areas for Lomestead purposes.

AND whereas the DONEE was one of such persons who had come to use and eccupy a piece of land particularly described in the schedule hereunder.

AND whereas the DONEE being a refugee displaced from East Pakistan (now Bangladesh) approached the Government of West Bengal for a plot of land for his rehabilitation.
