


It is agreed to enter into this agreement to give effect to the said transaction.



AND it has been lastly mutually agreed that the Retiring Partner shall release and assign his share, right and interest in the business of the partnership and all partnership assets, including the credits, and goodwill thereof including also the tenancy right, firm name, permits, licenses etc. belonging to the partnership unto and in favour of the Continuing and the New Partner absolutely.

NOW THIS DEED OF RETIRMENT AND ADMISSION OF A NEW PARTNER HEREBY WITNESSETH AS FOLLOWS:-

The Retiring Partner hereby assigns and transfer all his share, right title and interest in the said partnership business together with all the assets including goodwill and all outstandings, benefits of all permits and licences held by the firm, to hold the same unto the New Partner absolutely but subject to all debts and liabilities of the Firm.

- 4. That the Retiring Party shall not be entitled to use and /or carry on business under the name "M/s Asmi Construction" or any name similar thereto.
- 5. The Continuing Partner admit the New Partner as a Partner of the said Partnership in place of the Retiring Partner and on the basis of the same terms and conditions as are contained in the said Deed of Reconstitution as on 01st Day of April, 2010. Hereinbefore recited as if the New Partner was a party to the said Deed of Reconstitution (dated 01.04.2010) in place or stead of the Retiring Partner except that the New Partner will not be entitled to the benefits by way of profits earned during the period upto the date of these presents.
