In reference to your Consent to Establish application for project mentioned above, this is to inform you that the West Bengal Pollution Control Board has scrutinized and processed your WBOCMMS application no. **6658600** having project cost of **Rs. 50203** lakhs for which payment of necessary fees duly received.
