SHOWN IN RED BORDER



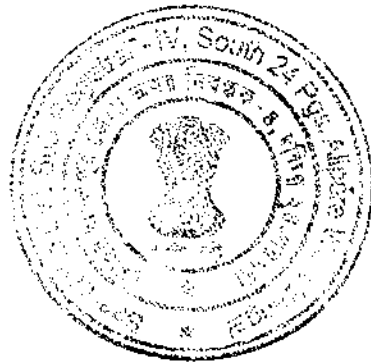

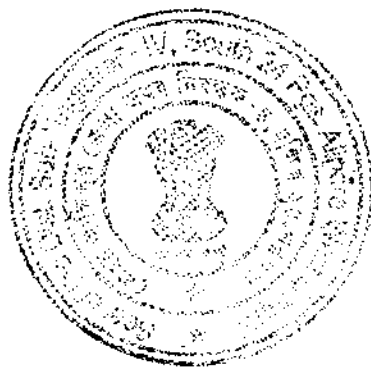

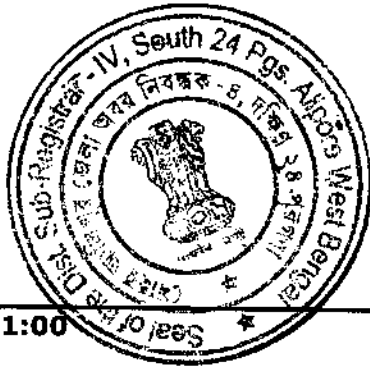
