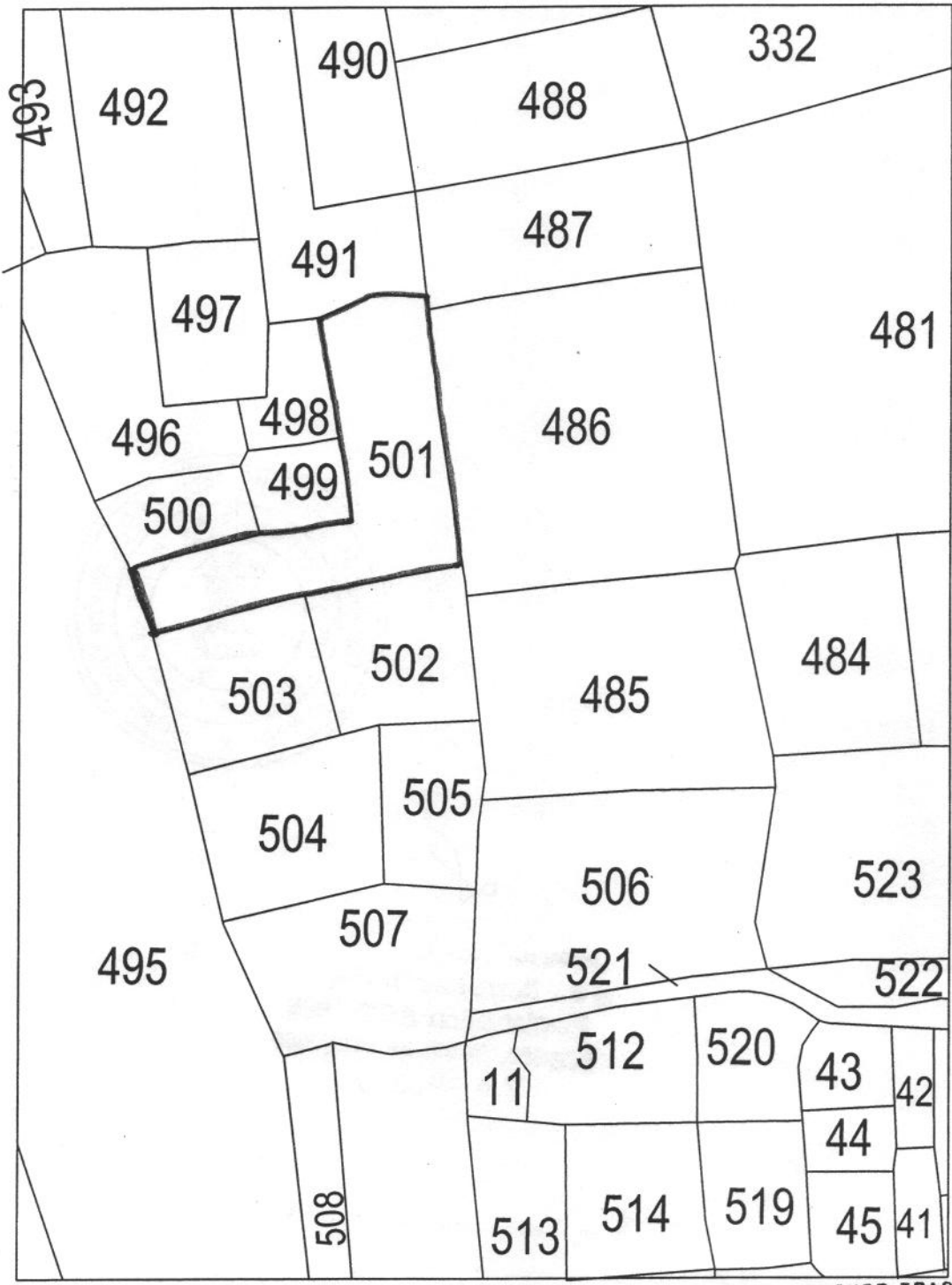

SHOWN IN RED BORDER

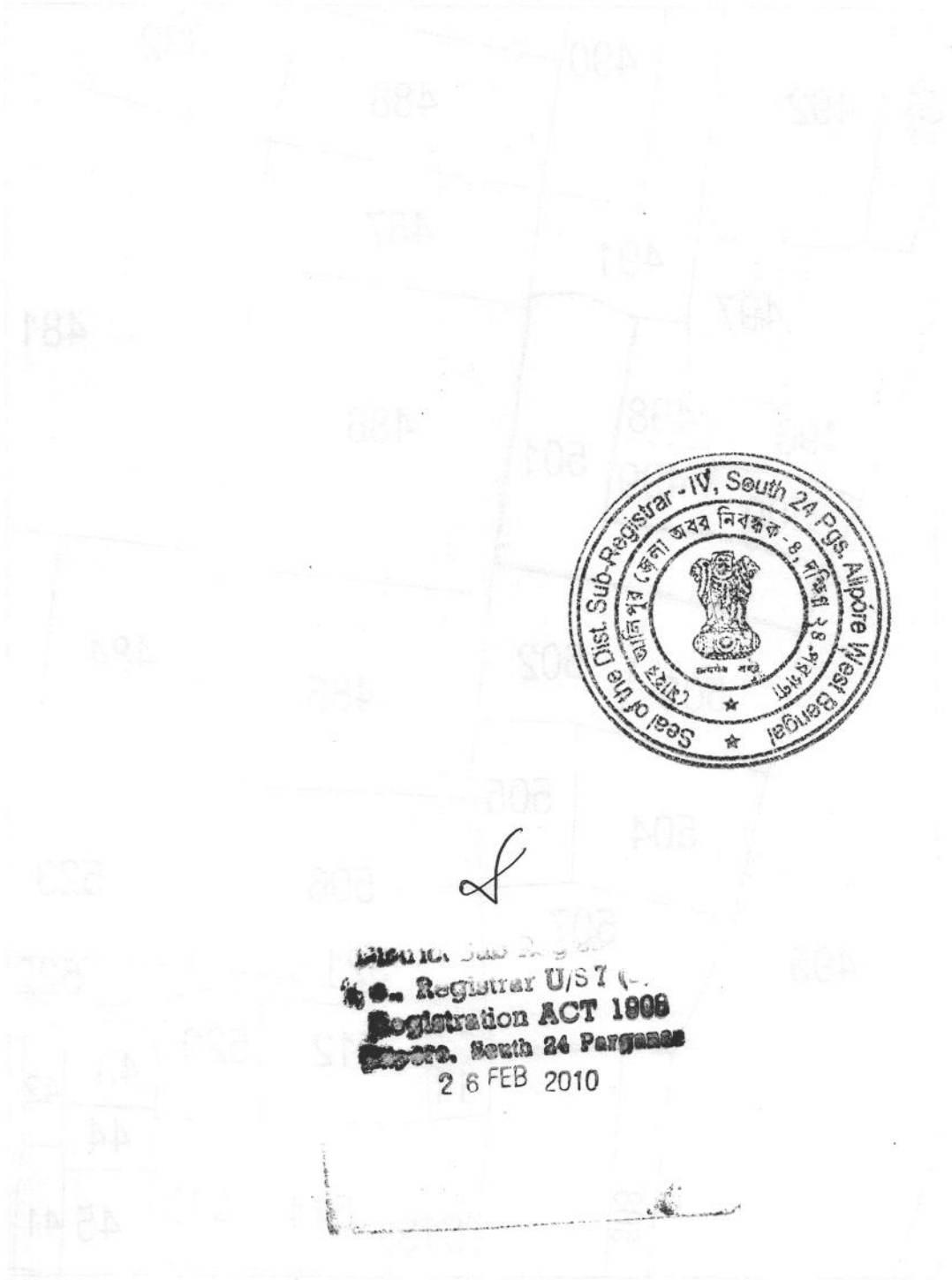
