- 1. That Rajesh Kejriwal and Krishnamurti Foundation India have a legal title to the land on which the development of the proposed project at 44/3, Hazra Road, Kolkata 700 019, PS Ballygunge is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner Rajesh Kejriwal and Krishnamurti Foundation India and promoters (Satvic Projects Pvt. Ltd.) for development of the real estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by Promoter is 30^{th} June 2029.
- 4. That seventy per cent of the amount realised by Promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- 6. That the amount from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That the Promoter shall get the accounts audited within six month after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That Promoter shall take all the pending approval on time, from the competent authorities.
