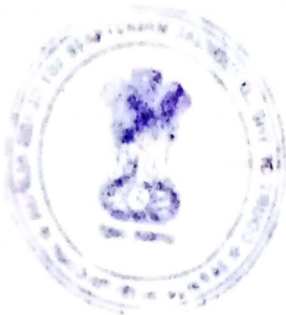

1. That one Satish Chandra Biswas, son of late Nilkanth Biswas, absolute owner of ALL THAT piece and parcel of land measuring about more or less 8 Cottahs 5 Chittacks and 27 sq. ft. equivalent of land lying and situated at Mouza Krishnapur, J.L. No. 228/229, R. S. Khatian Nos. 129 & 130, R.S. Plot (Dag) Nos. 4288 at Krishnapur Mission Bazar, P.O. Krishnapur, P.S. New Town (formerly Rajarhat), Registration Office ADSR Rajarhat within the local limits of Bidhannagar Municipal Corporation previously Rajarhat Gopalpur Municipality under Ward No.15 (Old) and 26 (New) and Municipal Holding No. RGM/15/1902 in the District of 24 Parganas (North).



2. That Satish Chandra Biswas in his lifetime bequeathed the property mentioned in the foregoing paragraph, in favour of his wife Late Maya Rani Biswas (who died on 05.07.2008) and daughter Late Bhagabati Biswas (who died unmarried on 17.11.2013) by his last will and testament.

3. That the said Satish Chandra Biswas died on 22nd day of February 2006 leaving behind his wife namely Maya Rani Biswas and her elder daughter namely Ms. Bhagawati Biswas as his legatees/beneficiaries under the aforesaid Will in respect of the aforesaid property.

4. That upon the death of the said Satish Chandra Biswas, the named Executrix of the aforesaid Will applied for grant of Probate before the Hon'ble High Court at Calcutta being P.L.A. No. 266 of 2006 of the Last Will and Testament dated 23rd day of December 2005 of the said Satish Chandra Biswas. The probate was granted by the Hon'ble High Court, Calcutta on 26th day of April, 2007

5. That the said Late Maya Rani Biswas died intestate on 05.07.2008 leaving behind Bhagabati Biswas as unmarried daughter, Parimal Biswas as son, Kankabati Parui wife of Subal Ch Parui as married daughter, Sagarika Kayal wife of Krishnendu Kayal as married daughter, Raja Parui and Debjani Ghosh as grandchildren from predeceased daughter Saraswati Parui. Upon death of Maya Rani Biswas, her undivided share devolved upon the aforesaid persons as Class-I heir by operation of Hindu Law of Succession 1956 in equal share.

6. That thereafter Bhagawati Biswas died intestate on 17.11.2013 leaving behind the following persons: Parimal Biswas as brother, Kankabati Parui wife of Subal Ch Parui as married sister, Sagarika Kayal wife of Krishnendu Kayal as married sister, Raja Parui and Debjani Ghosh as nephews and niece from predeceased sister Saraswati Parui. Upon death of Bhagawati Biswas, her undivided share devolved upon the aforesaid persons as Class-I heir by operation of Hindu Law of Succession 1956 in equal share.

7. That Parimal Biswas, only son of late Satish Chandra Biswas and Mayarani Biswas died intestate on 28.10.2020 leaving behind Partha

Biswas, Sanjit Biswas, Paramita Biswas, Pampa Biswas, Sharmila Biswas, Late Mayarani Biswas and Late Bhagawati Biswas his sons and daughters. The wife of Parimal Biswas name Late Mayarani Biswas predeceased her husband.



8. That under the aforesaid circumstances the following persons are the Class – I heirs of Late Mayarani Biswas and Late Bhagawati Biswas:
