possession of the [Apartment/Plot] is the essence of the Agreement. The Promoter, based on the approved plans and specifications, assures to handover possession of the [Apartment/Plot] on unlessthereisdelayorfailureduetowar,flood,drought,fire,cyclone, earthquake or any other calamity caused development of by nature affecting the regular project("ForceMajeure").If,however,thecompletionoftheProjectisdelayedduetotheForce Majeure conditions then the Allottee agrees that the Promoter shall be entitled to the extension of time fordeliveryof possessionof the [Apartment/Plot], provided that such Force Majeure conditions are not of a nature which make it impossible for the contract Allottee agrees to be implemented.
