- I, <u>ASHOK KUMAR GUPTA</u>, <u>PARTNER</u>, <u>ON BEHALF OF M/S KESSO</u> <u>REALTY LLP</u> promoter of the proposed project, do hereby solemnly declare, undertake and state as under:
- 1. That I / promoter have/ has a legal title to the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by us/promoter is 30-09-2027.
- 4. That seventy per cent of the amounts realized by the promoter for the real estate project from the allottees from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the Reproject shall be withdrawn in proportion to the percentage of the completion and the project.
- 6. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn only after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That I /promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
 - **8**. That I / promoter shall take all the pending approvals on time, from the competent authorities.
 - **9**. That I / promoter has furnished such other documents as have been specified by the rules and regulations made under the act.
