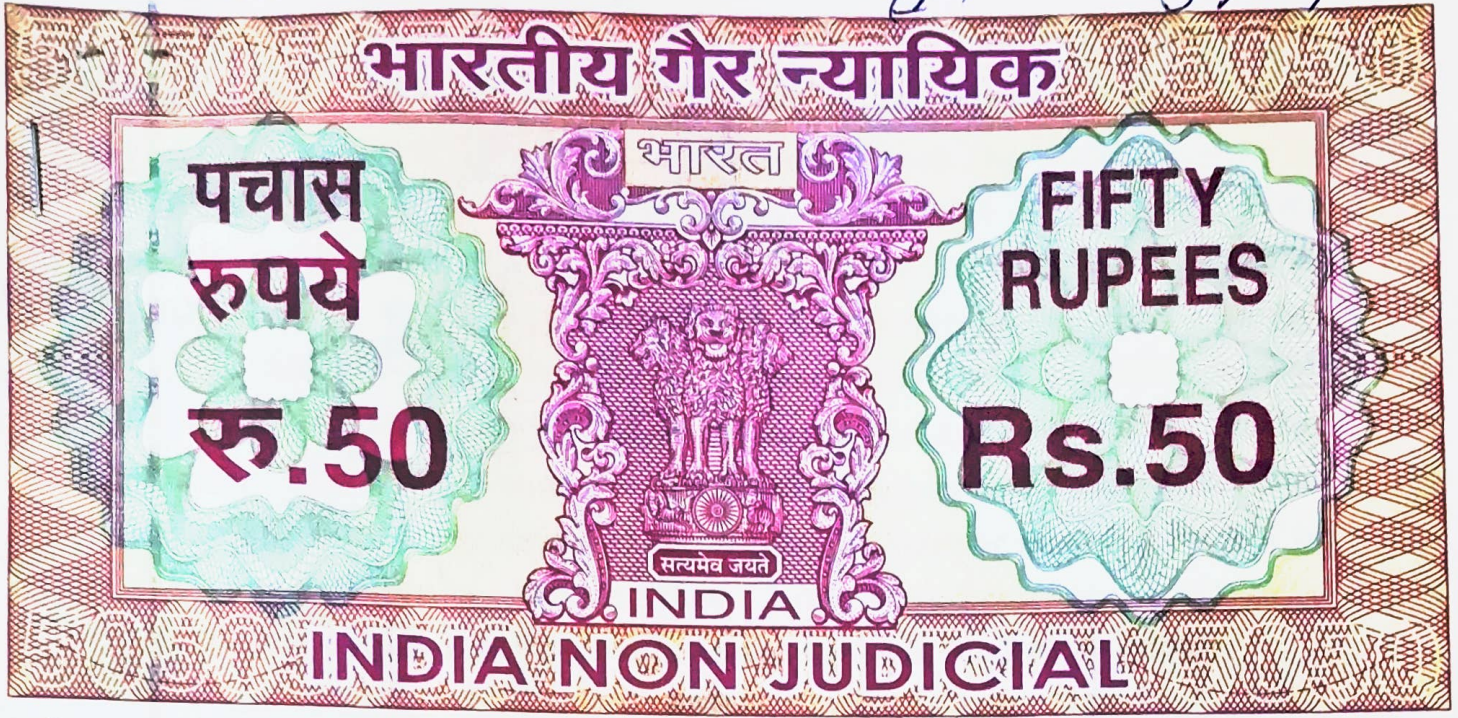

a) In the 7th line, in in serial ii) of the part I of the said schedule "A" at page 17 of the said agreement, the R. S. plot no. being the figure "no. 341" after the words "R. S. Dag no." and before the words "and L. R. Dag no." is inserted and read as such.

b) and in the 10th line, in in serial ii) of the part I of the said schedule "A" at page 17 of the said agreement, the R. S. plot no. being the figure "no. 341" after the words "R. S. Dag no." and before the words "and L. R. Dag no." is inserted and read as such.

AND WHEREAS that as rectified and modified as aforesaid and as stated in the **SCHEDULE** hereunder stated the serial ii) of the part I of the said schedule A of the said agreement entered into by and between the parties hereinbefore stated shall remain in full force and effect.
