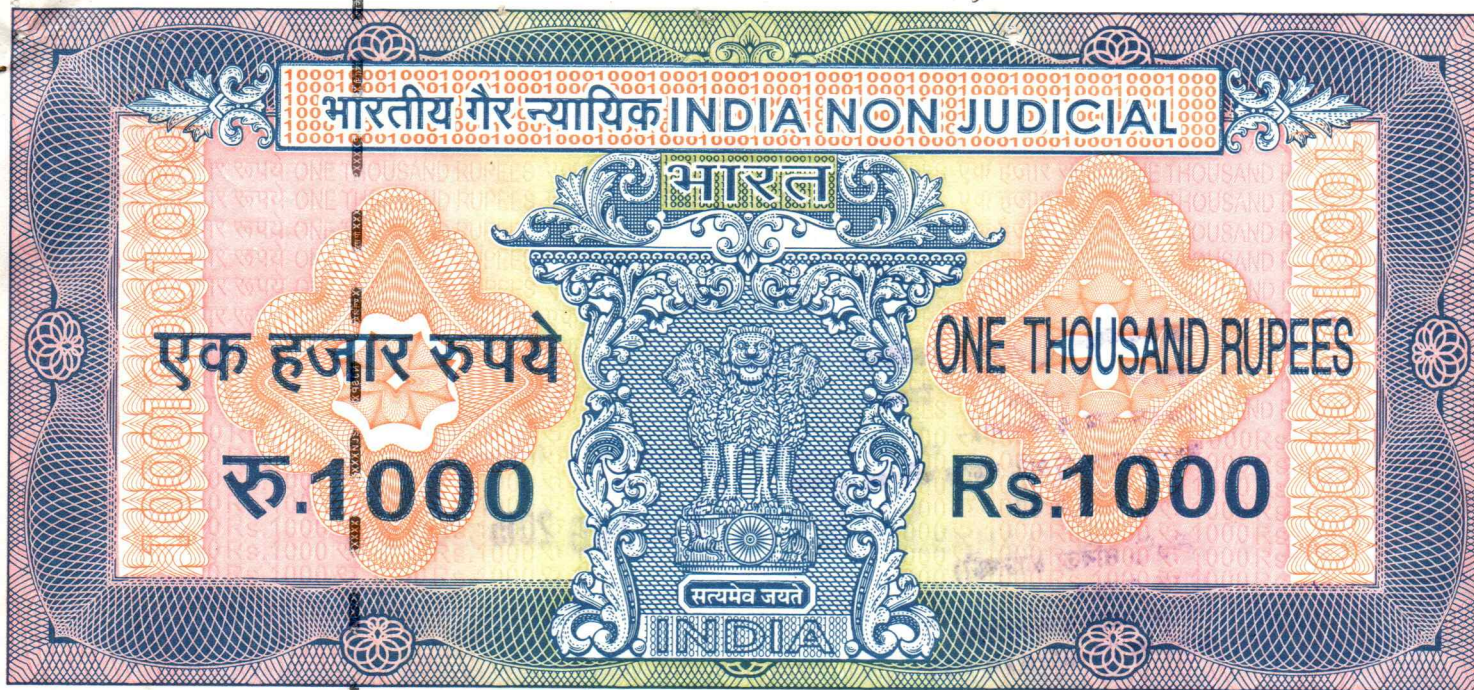

Asansol, District:-Burdwan, West Bengal, India, PIN - 713303, hereinafter called the **DONOR** (which expression shall unless excluded by or repugnant to the context include all of her heirs, successors, representatives and assigns) of the **ONE PART**.

Asansol, District:-Burdwan, West Bengal, India, PIN - 713303, hereinafter called the **DONEE** (which expression shall unless excluded by or repugnant to the context include all of his heirs, successors, representatives and assigns) of the **OTHER PART**.

WHEREAS the property morefully mentioned in the Part-I of the Schedule 'A' in the R.S. Plot No. 889 comprising in L.R. Plot No. 1071 and R.S. Plot No. 885 comprising in L.R. AND WHEREAS aforesaid Ramesh Chandra Ghosh while in peaceful possession of the aforesaid property, died intestate leaving behind his wife i.e. the Donor herein and two sons namely Sri Subir Ghose & Prabir Ghose i.e. the Donee herein, as his sole legal heirs and successors to inherit 1/3rd each of the aforesaid property by way of inheritance as per Hindu Successor Act. 1956.

AND WHEREAS the above named Donor out of her natural love and affection toward her son i.e. above named Donee have declared her intention to make absolute Gift of her schedule below property which is morefully mentioned in the schedule 'B' below in favour of her son and the Donee also agreed to accept such Gift with due forever and respect hereby conveyed by the Donor.

AND WHEREAS the property mentioned and described in the schedule 'B' below hereby gifted by the Donor in favour of the Donee is free from all encumbrances.

NOW THIS DEED OF GIFT WITNESSES AS FOLLOWS :-

THAT in pursuance of the said intentioned and in consideration of natural love and affection which the said Donor has for the said Donee, the said Donor out of her own free will and accord without fraud, coercion or undue influence from any body whatsoever and in full possession of her sense does hereby gives, convey, grant, transfer, assign and confirm unto the said Donee all that part and parcel of land with building mentioned and described in the schedule below.

TO HAVE AND TO HOLD the said property hereditaments hereby gifted unto and to the use of the said Donee for ever and absolutely.

AND THAT the said Donee shall and may from time to time and at all times hereafter peaceably and quietly enter upon, have, hold, occupy, possess and enjoy the said 'B' schedule property hereby gifted and receive and take the rents, issues and profits and thereof and every part thereof without any let hindrances whatsoever from or by the said Donor or by any person/persons claiming from under or in trust of her.

AND THAT the said Donee accepts the gift of the said 'B' schedule property hereunder mentioned and described in the schedule below.

AND THAT the Donor has given physical possession of the said property mentioned and described in the schedule 'B' below to the Donee who has entered into and upon the said land hereby conveyed and the Donee will enjoy the same from generation to generation and other heirs, successors, executors and legal representatives of the said Donor shall not claim any right, title and interest in the said property in future.



AND THAT the Donee shall have every right to change the nature and character and to raise new building or structure on the said 'B' schedule property if and when required for the same.

AND THAT the Donee will be entitled to have his name mutated in the Municipal Registrar at Asansol Municipal Corporation and in the Sheresta of State of West Bengal in respect of the said land mentioned and described in the schedule 'B' below through S.D.L. & L.R.O., Extn. Part-I, Asansol hereby gifted and shall pay all rents, cesses and taxes in respect of the said property.

AND THAT with the execution of this Deed, the Donee have become the joint and absolute owner of the said land with building mentioned and described in the schedule 'B' below.
