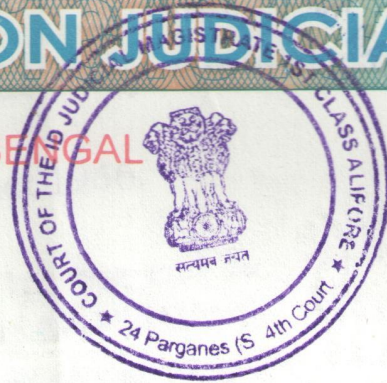

4) That my Grand father & Grand Mother passed away long time ago before my Father & Mother death.

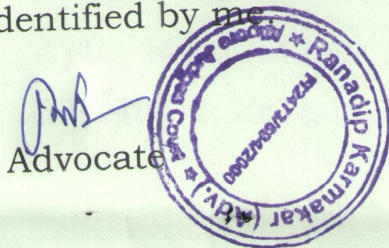
5) The above declaration is true to my knowledge.
