- Permanent Account Number (PAN) facilitate Income Tax Department linking of various documents, including payment of taxes, assessment of income tax returns, matching of information and easy maintenance & retrieval of electronic information etc. relating to a taxpayer.

- Issuance of PAN is now mandatory for several transactions specified under Income Tax Act, 1961 (Refer Rule 114B of Income Tax Rules, 1962).

- Possessing or using more than one PAN is against the law & may attract penalty of upto Rs. 10,000.

- The PAN Card enclosed contains Enhanced QR Code which is readable by a specific Android Mobile App. Keyword to search this app is "Enhanced QR Code Reader for PAN Card".
