Your site is located at a distance 10513 mts from ARP and lies in the grid P11 of the published CCZM of Behala airport. The Permitted top elevation for this grid is 150 mts.

Since the requested top elevation 98.5 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.
