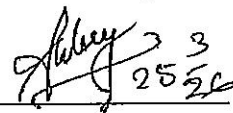

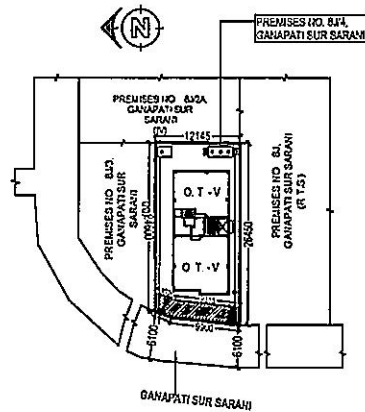

WARD NO. -02 , BOROUGH -I , FOR KMDA NOC U/S 393(A) OF K.M.C. ACT B/R 2009

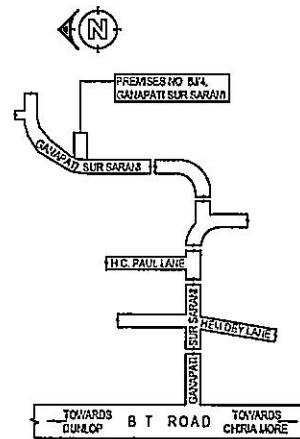
