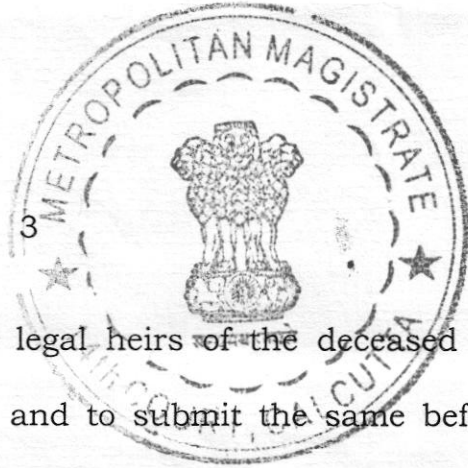
1. That along with my family members all are citizens of
