Offices at Howrah on and from 1996 to 2025 and upon perusal of the respective Searching Reports in respect of said Registration Offices, submitted by the above Searcher as well as upon going through the 'Contents' of all relevant Legal Papers and Documents of Title including Case Papers, L.R. Record of Right and Assessment Register & Death Certificate, it appears on enquiry that the above Property (Viz. 19, Guha Park, P.O. & P.S. – Liluah, District – Howrah, PIN – 711204) was formerly known and identified as Holding No. 8, Guha Park measuring all together 44 (Forty) Four Cottahs 2 (Two) Chittacks 15 (Fifteen) Sq.ft. Mokorari Mourashi Bastu Land with old Structures existed thereupon, hereinafter called and referred to as the Said Property, originally belonged to one PANNALAL LOONIA @ LUNIA (Son of Late Dhanraj Lunia), since deceased, as absolute owner in perpetuity who used to be 'KARTA' of Hindu Undivided Family under the name and style of PANNALAL LOONIA (HUF), having purchased and/or acquired the aforesaid Property by virtue of a Regd. Deed of Sale dated 08.06.1931, registered in the then Sadar Joint Sub-Registrar at Howrah and recorded in Book No. I,

Volume No. 14, Pages from 235 to 239, being No. 1041, for the year 1931, in the name of his Eldest Son - JASKARAN LUNIA but the entire Consideration Money paid to the then "Vendors" viz. Dharam Chand Surana & Ors. under the aforesaid Deed of Sale dated 08.06.1931, Being No. 1041/1931, by said Pannalal Lunia himself out of his own fund or contribution and as such, said Property had all times considered as JOINT FAMILY PROPERTY of aforesaid HUF which was consisted of said Pannalal Lunia himself and his four sons namely (1) Jaskaran Lunia, (2) Chandan Mal Lunia, (3) Narendra Lunia and (4) Kanhaiyalal Lunia respectively.

After the death of said Pannalal Lunia, his eldest son - Jaskaran Lunia became the KARTA of aforesaid HUF and subsequently, upon the death of said Jaskaran Lunia on 12.09.2000, Mr. Kanhaiya Lal Lunia being next eldest member of said Lunia Family, became the KARTA of above HUF and continued to run and maintain the above Family Properties by himself on behalf of other family members of said Lunia Family who by passage of time instituted one CIVIL SUIT being T.S. No. 159 of 2001 on behalf of said HUF against other Family Members in the Court of Ld. 6th Civil Judge (Jr. Divn.) at Howrah which was registered as T.S. No. 159 of 2001 and said Suit was ultimately Decreed on Compromise in terms of a Solenama Petition filed on behalf of both Parties to the above Suit vide Order No.11, dated 17.09.2002 and accordingly, on the basis of above Compromise Decree dated 17.09.2002, said Property was declared and be treated as JOINT FAMILY PROPERTY under the name and style of PANNALAL LUNIA (HUF) of which, Kanhaiyalal Lunia was the then KARTA and all other

Defendants of that Suit were/are to be treated as Co-sharers of above Property having equal right, title, interest and possession therein.

In terms of above Compromise Decree dated 17.09.2002 Said Property was duly mutated both in the L.R. Record of Right as 'RAIYAT' in the name of PANNALAL LOONIA (HUF) and also as "Owner and Occupier" in the Assessment Register of Howrah Municipal Corporation which since been assigned and re-constituted under the jurisdiction of Bally Municipality at present under Ward No. 32 and former Holding No. 8, Guha Park now re-numbered and known as 19, Guha Park, P.O. & Police Station – Liluah, District – Howrah.

That subsequently, said Kanhaiyalal Lunia died on 29.09.2011 and upon his death, Surendra Kr. Lunia @ Loonia (Son of Late Jaskaran Lunia) as next eldest member of said Lunia Family, stepped into his shoes and became the KARTA of above HUF and has been enjoying/maintaining the above Property on behalf of other members of said Lunia Family who also mutated his name as KARTA in the relevant Record of Right vide L.R. Khatian No. 6030, L.R. Dag No. 1791 within Mouza and Police Station – Liluah, J.L. No. 12, District – Howrah, PIN – 711204.

It further appears on enquiry that said PANNALAL LUNIA (HUF) represented by its KARTA – SURENDRA KUMAR LUNIA is the sole, exclusive and absolute owner of the SAID PROPERTY at Bally Municipality Holding No. 19, Guha Park, P.O. and Police Station – Liluah, Ward No. 32, District – Howrah, PIN – 711204 and is in actual physical possession of the same partly in khas and partly through Tenants without any interference upto
