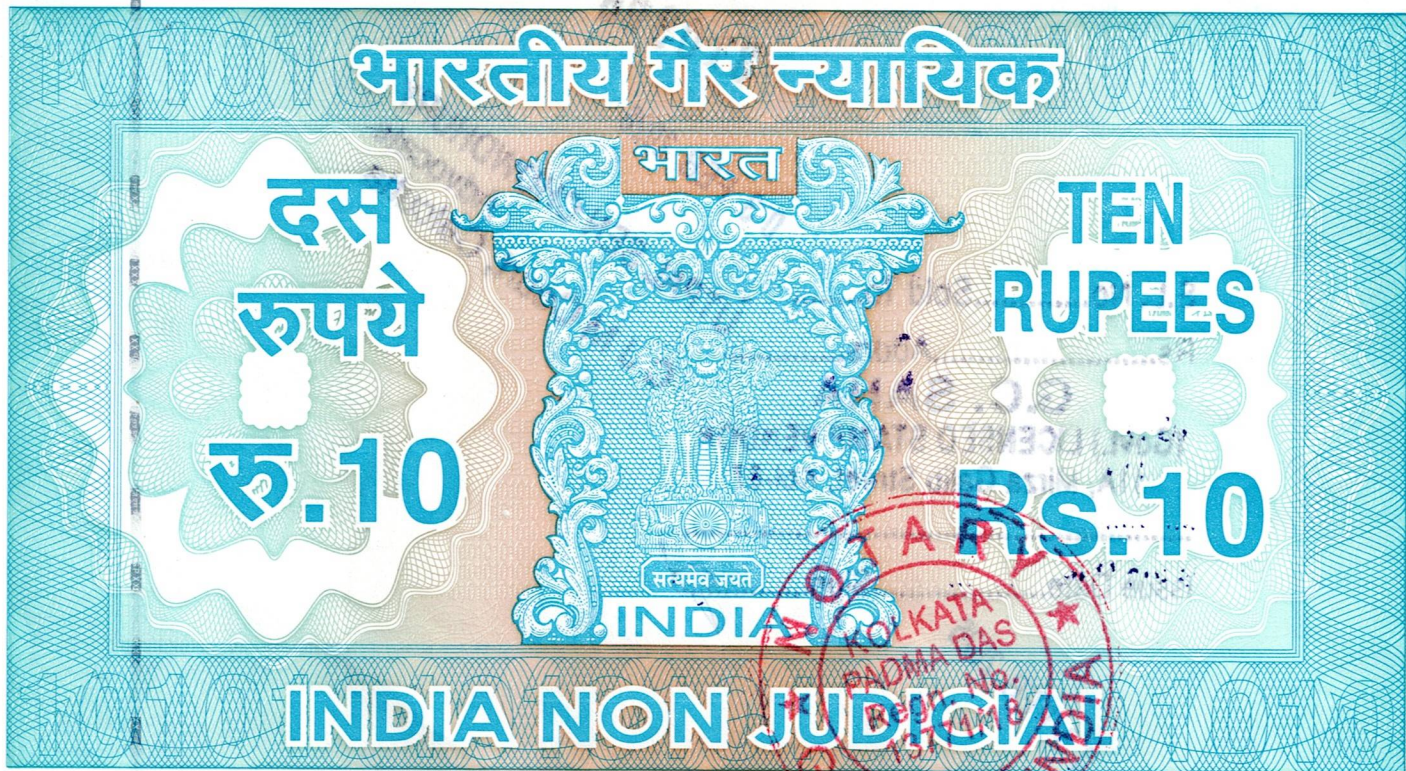

maintain in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose .

5. That the amount from the separate account , to cover the cost of project shall be withdrawn in proportion to the percentage of completion of the project .
6. That the amount from the separate account , that the withdrawn after its certified by an engineer an architect and a chartered accountant in practice , that the withdrawal is proportion to ,the percentage of completion of the project .
