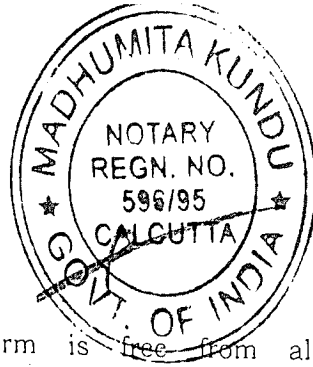
2. **COMMENCEMENT:-** That the partnership having already commenced on and from 1st day of March, 2004 constituted and reconstituted and continuing accordingly.

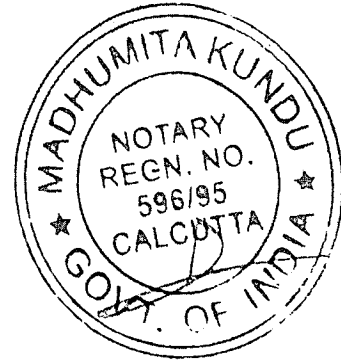

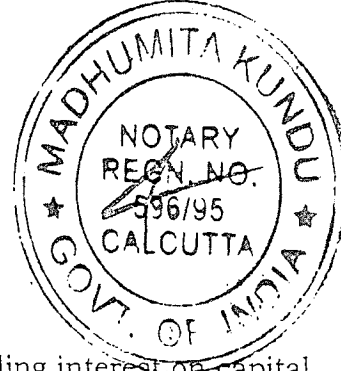


8.
