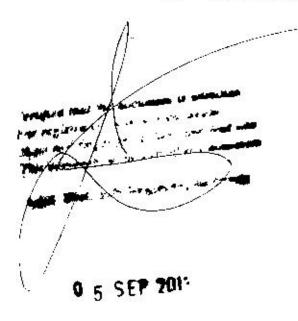

5. Background:

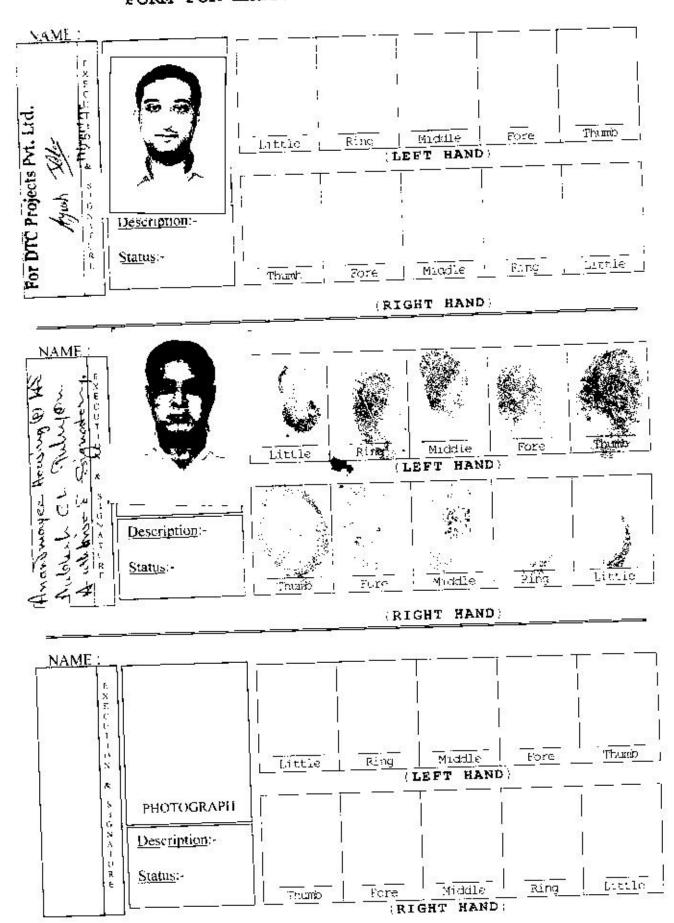

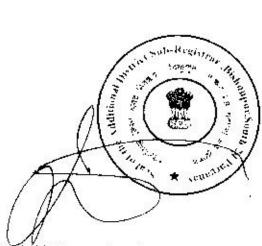
