#### 5. Background:

only, the entirety of which has been paid and or to be paid by the Purchaser to the Vendor in the manner as follows:

One Universal Electric Limited was the absolute owner of all that piece and parcel of land measuring an area of 2970 Decimals, more or less, in Mouza Daulatpur and Hanspukuria in the District of 24-Parganas (the "Total Land") acquired by it by thirty several Indentures of Conveyances on various dates between 26th December, 1961 and 23th June, 1962.
- By an order dated 9th January, 1986 passed by the Hon'ble High Court at Calcutta in Company Petition No. 428 of 1984 connected with Company Application No. 132 of 1984 the scheme of amalgamation made between the said Universal Electrics Limited and Shree Digvijaya Woolen Mills Limited was sanctioned and it was declared that the same would be effective from 1th July.

- D. The name of the said Shree Digvijaya Woolen Mills I imited was changed to VXI. India Limited and a fresh certificate of incorporation consequent on such change was issued by the Registrar of Companies, Gujarat on 13th June, 1986.
- E. The name of the said VXI. India Limited was further changed to Birla VXI. Limited and a fresh certificate of incorporation consequent on such change was issued by the Registrer of Companies, on 5th April. 1995.
- 1. By an Indenture of Conveyance dated 23<sup>rd</sup> day of September, 1998 made between Birla VXi Limited therein referred to as the Vendor of the one part and VXL Landis & Gyr Limited therein referred to as the Purchaser of the other part and registered with the Registrar of Assurances, Calcutta in Book No. I, Volume No.110, Pages 346 to 407, Being No.5943 for the year 2001, the said Vendor therein granted, transferred, conveyed, assigned and assured unto and in favour of the Purchaser therein for the consideration therein mentioned all that the piece and parcel of freehold land having an area of land measuring 1980 Decimals, he the same a little more or tess, in Mouzas Daulatpur and Hanspukuria in the District of South 24-Parganas, out of the Total Land, as described in the Second Schedule there ender written (the "Said Land").
- G. The name of the said VXL Landis & Gyr Limited was further changed to Siemens Metering Limited and a fresh certificate of incorporation consequent on such change was issued by the Registrar of Companies, West Bengal, on 26th May, 2003.
- The name of the said Siemens Metering Limited was further changed to Lands \* Gyr I imited and a fresh certificate of incorporation consequent on such change was issued by the Registrar of Companies, West Bengal, on 27th May. 2003.

- Limited therein referred to as the Vendor of the one part and DTC Projects Private Limited therein referred to as the Porchaser of the other part and registered with the Registrar of Assurances, Calcutta in Book, No. 1, Volume No. 1, Pages 1 to 23, Being No. 8455 for the year 2005, the said Vendor therein granted, transferred, conveyed, assigned and assured unto and in favour of the said DTC Projects Private Limited for the consideration therein mentioned all that the piece and parcer of freehold land having an area of land measuring 952 Decimels, be the same a little more or less, in Mouzas Daulatpur and Hanspekuria in the District of South 24-Parganas, out of the Said Lond, as described in the Schedule there under written.




