4] That thereafter said Rani Bala Roy w/o Anil Krishna Roy died on 12/12/2007 and her husband Anil Krishna Roy S/o Late Harendra Nath Roy died on 23/7/2008 and they leaving behind their sons - Ardhendu Roy, Gopal Roy, Paltu Roy, Goutam Roy, Arabinda Roy and Amalendu Roy and three daughters - Jharna Biswas, Dipali Sarkar, Minati Mandal as their only legal heirs and they became the owners of 1/9th share each of the aforesaid land i.e. Ardhendu Roy became the owner of land measuring 613 square feet, Paltu Roy became the owner of land measuring 613 square feet, Amalendu Roy became the owner of land measuring 613 square feet, Arabinda Roy became the owner of land measuring 613 square feet.

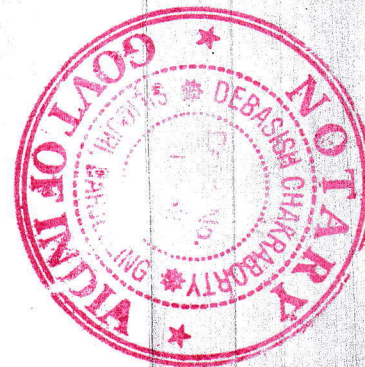

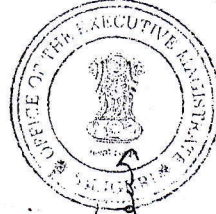

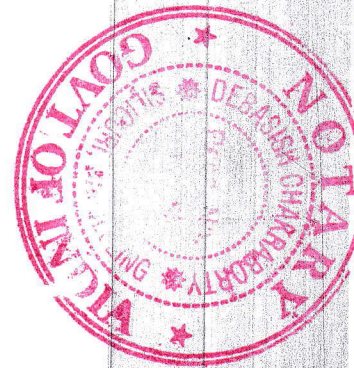
