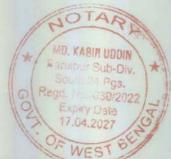

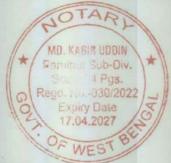
- 1. 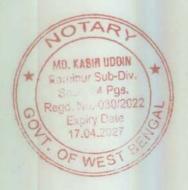
