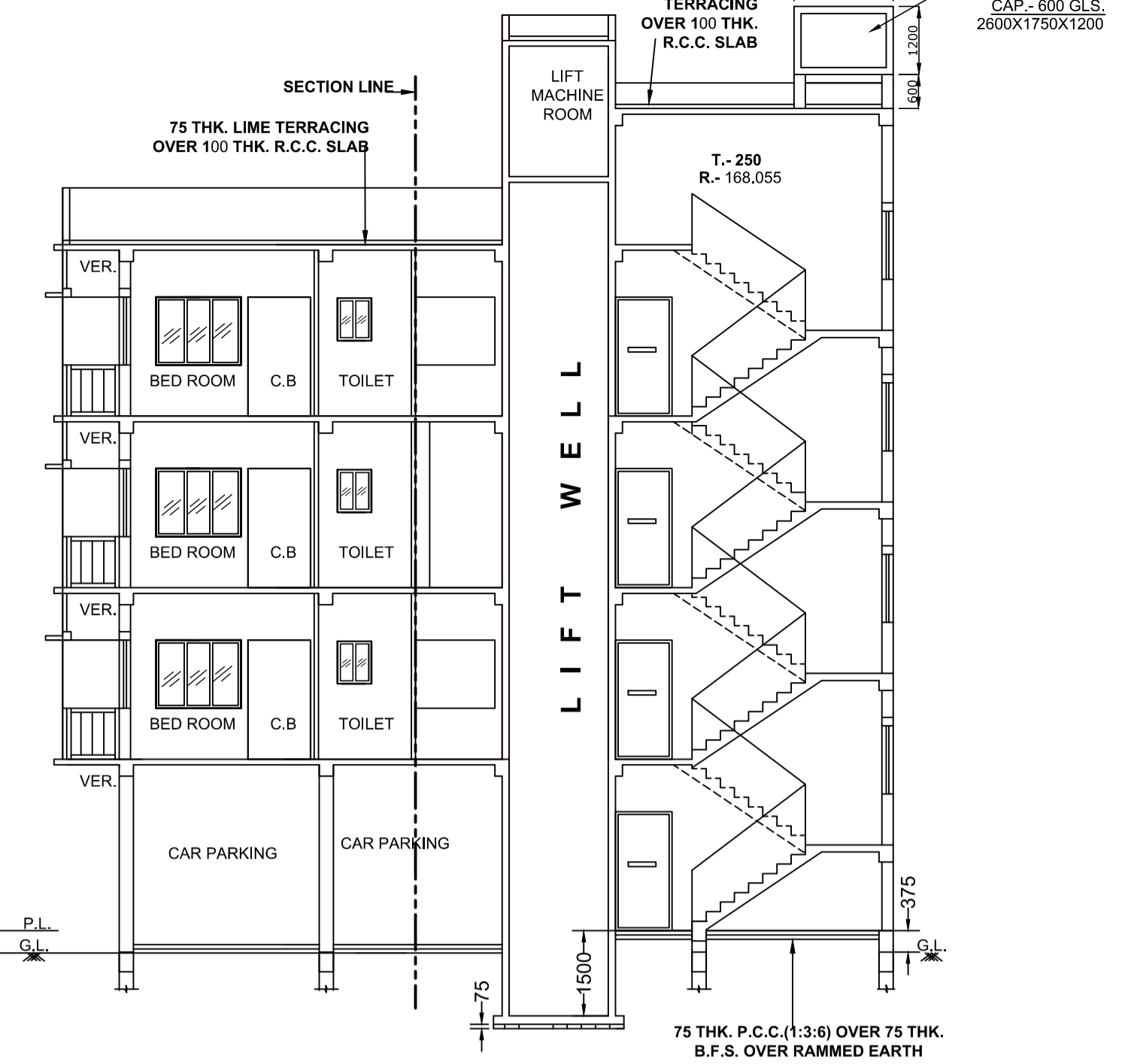

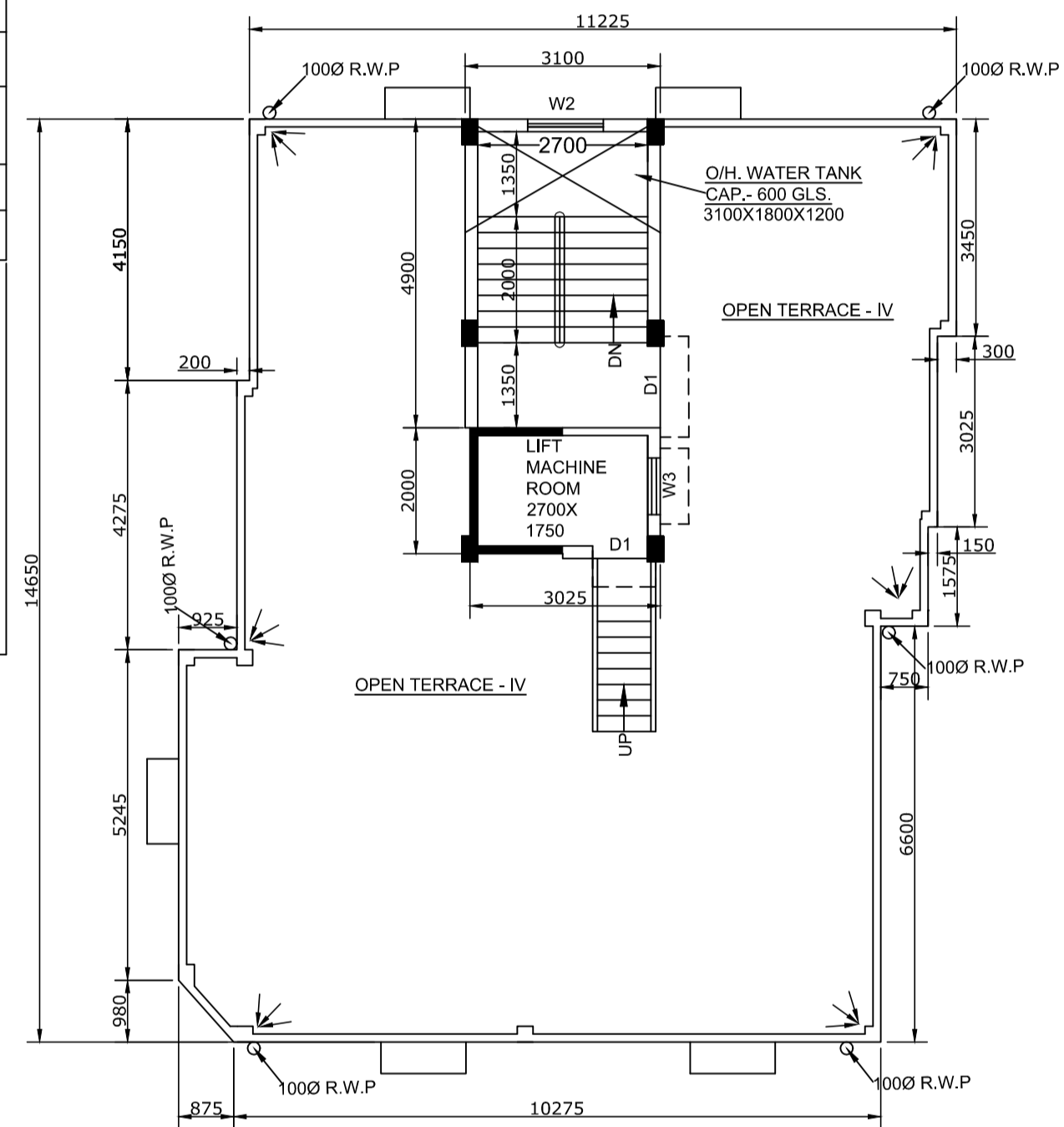


FRONT ELEVATION

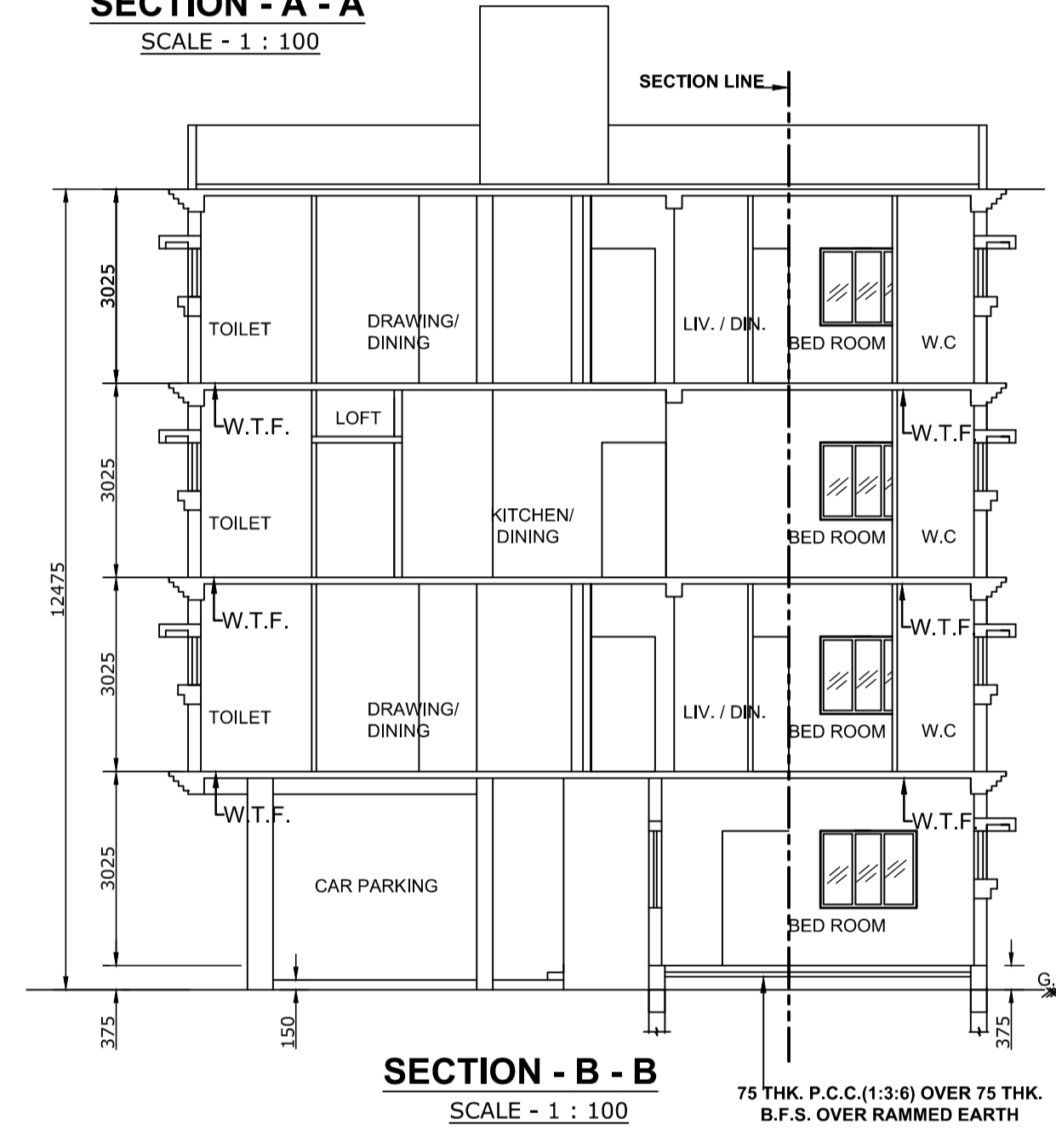
NORTH SIDE ELEVATION

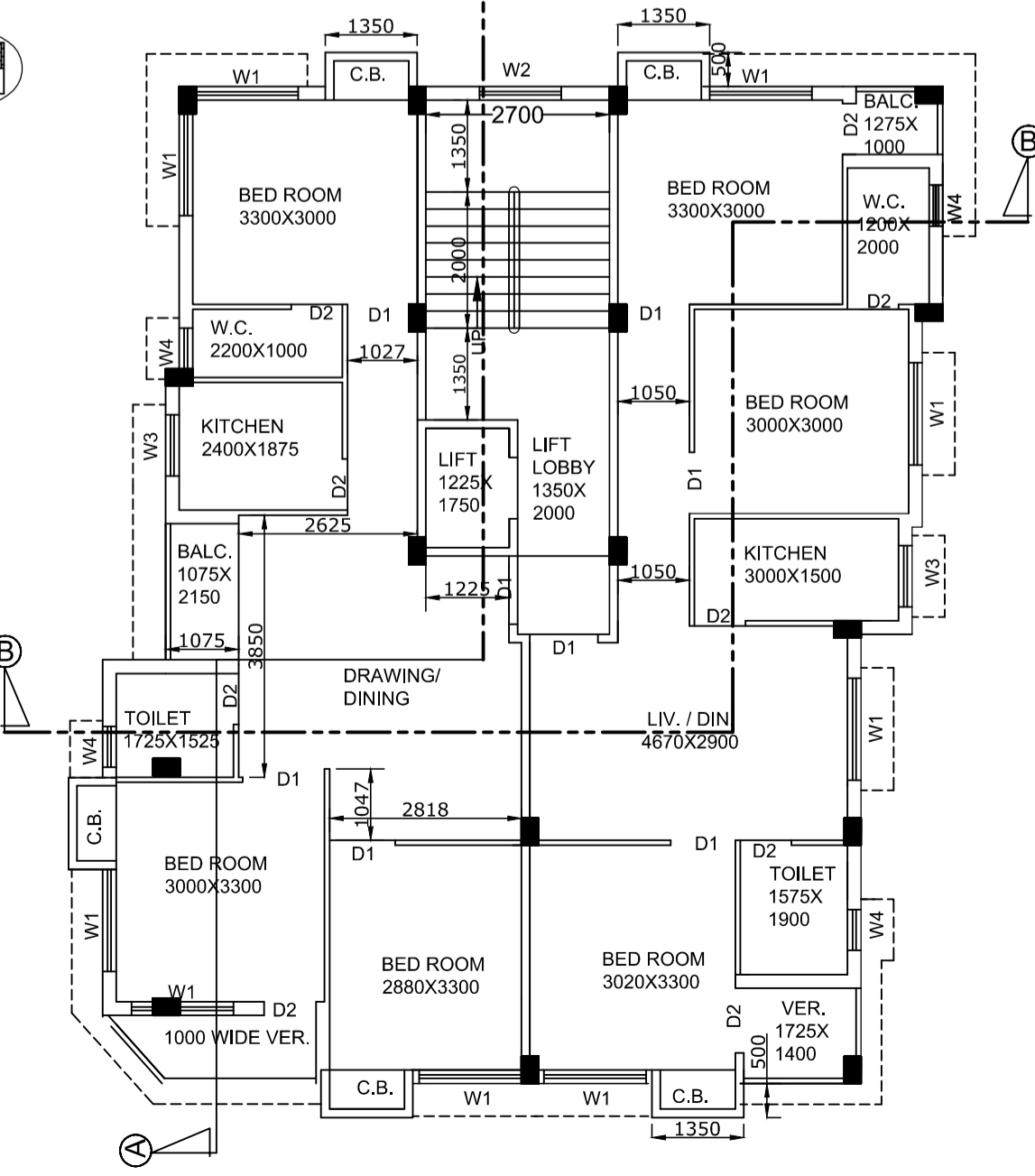
SECTION - A - A

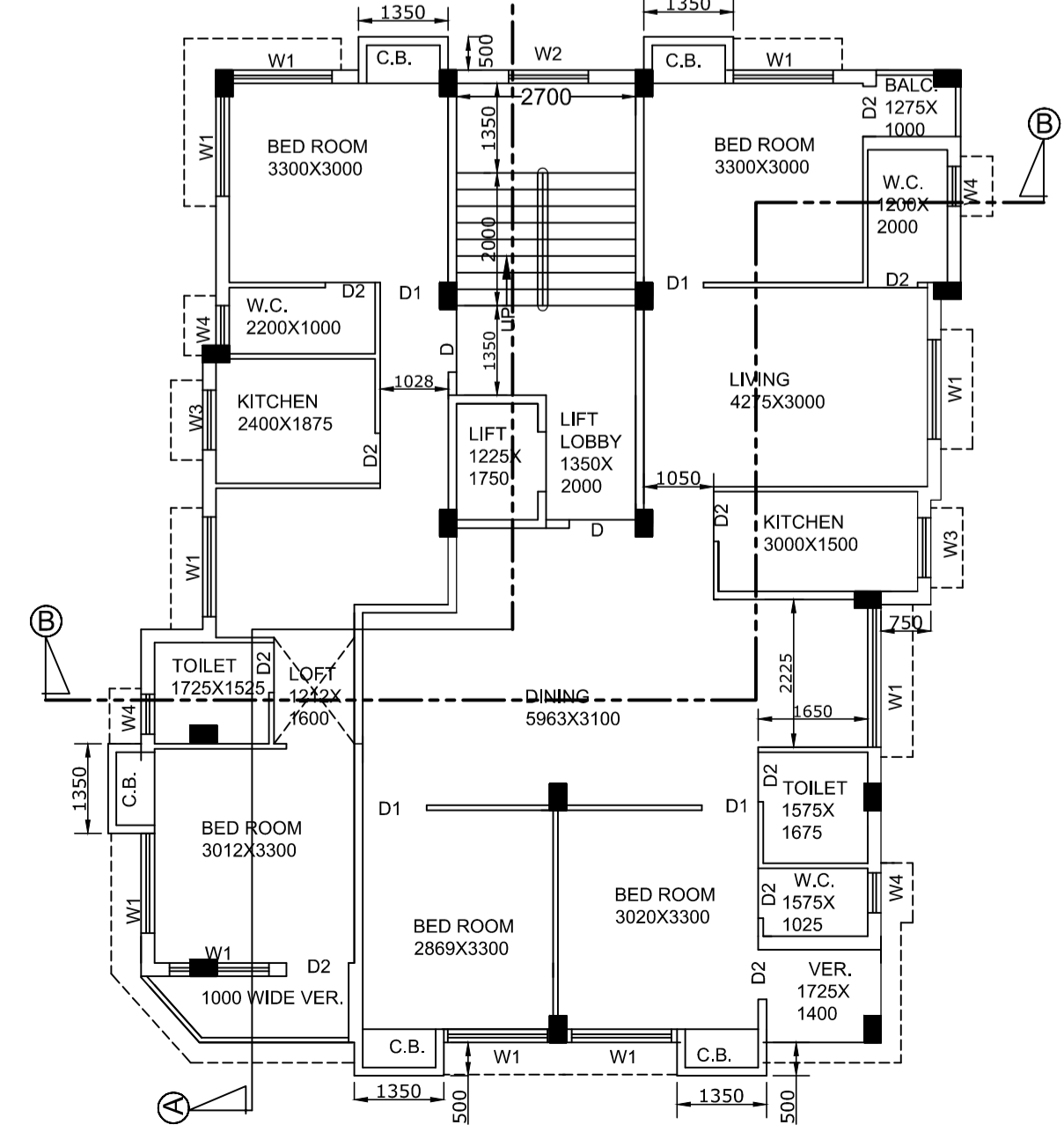
ROOF PLAN

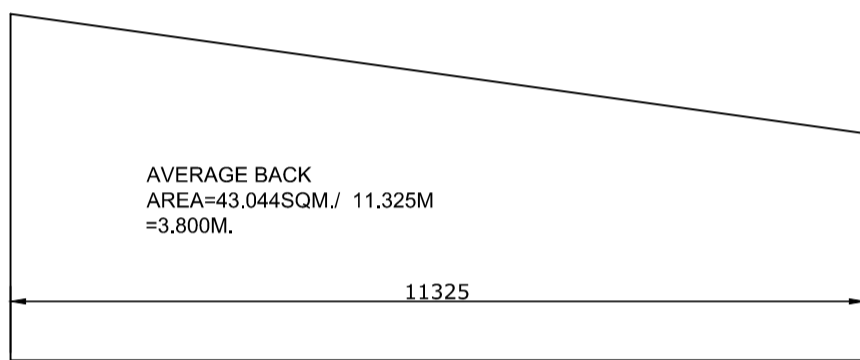

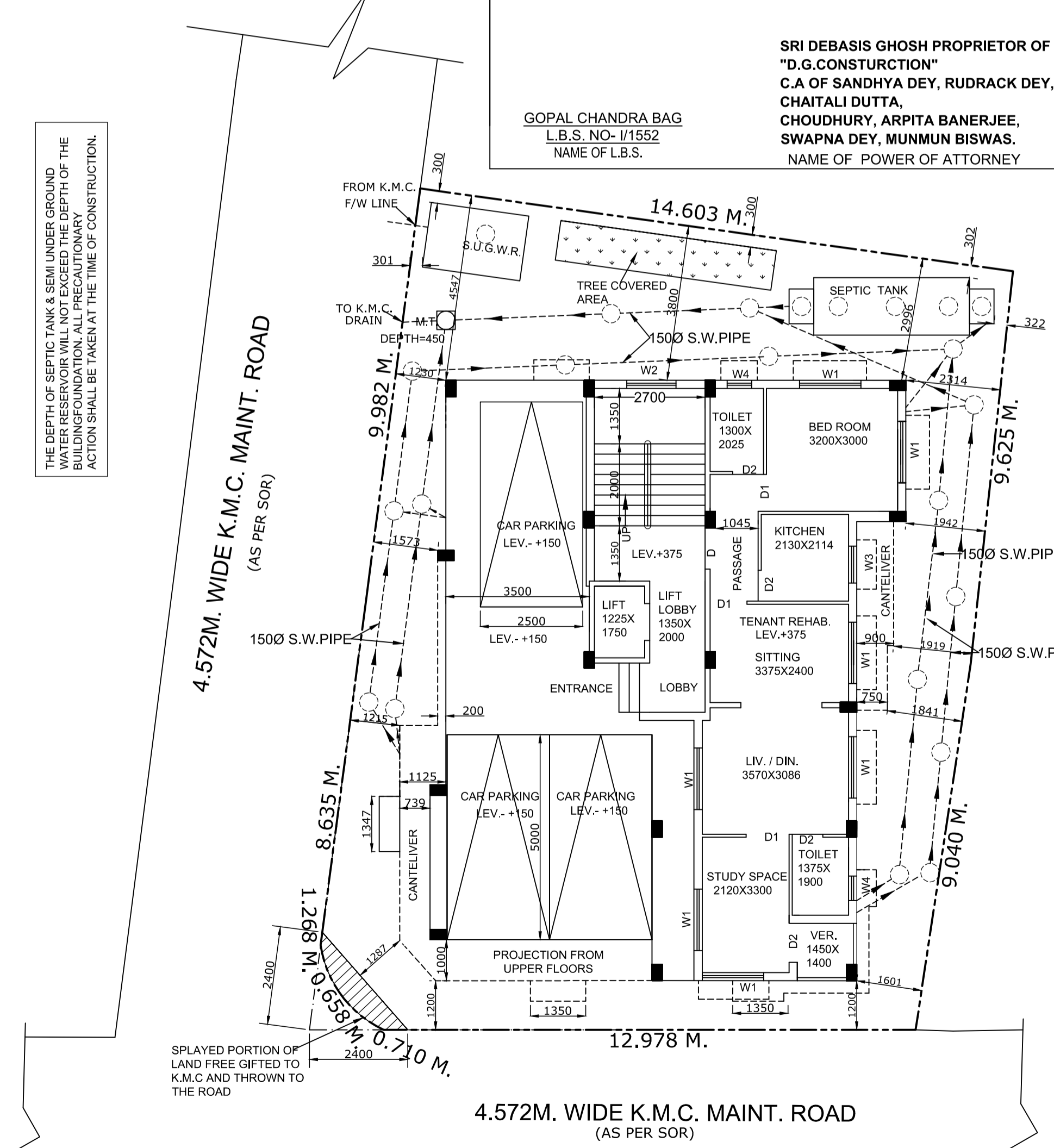
