	This is a case where the Complaint booked an apartment/flat from 'Dharitri	
	Infraventure Pvt. Ltd.' project of the Respondent in 2017 and agreement was	
	signed between the Complainant and the Respondent for the purchase of the	
	flat on 21.09.2018. The Complainant has paid Rs.1,83,625/-(Rupees one lakh	
	eighty three thousand six hundred twenty five only) to the Respondent	
	towards payment of total consideration money for the apartment. The	
	completion date of the apartment was December, 2020. However, the	
	Respondent failed to hand over the possession of the flat within this period.	
	The Complainant has now prayer for refund of the entire amount paid to the	
	Respondent for this flat.
