The case of the Complainant is that he booked a Plot No-D29 for the proposed project 'Royal Enclave' of the Respondent and paid Rs.25000/- but discovered afterwards that cultivation was going on in the proposed plot of construction and no construction is going to be held on the plot. He has applied for refund of application money on 11.01.2018 but till date he has not get any refund from the Respondent.

The Complainant prayed for refund of his application money with interest and compensation in his complaint petition.

The Respondent proposed for alternate flat at the time of hearing to the Complainant.

After hearing both the parties ,this Authority is satisfied to admit the matter as there are sufficient grounds as per WBHIRA Act and Rules for further hearing and direct the Respondent to take initiative and give proposal for alternate flat/s and arrange for inspection of the same by the Complainant.
