	The case of the complainant is that she booked on 13.12.2017, a 3 BHK flat	
	having area of around 906.25 sq-ft in the Evanie Econest project of the	
	Respondent company.	
	She has made a total payment of Rs. 7,53,811/- to the Respondent in this	
	regard and an Agreement for Sell was executed by the Respondent with the	
	Complainant on 02.06.2018.	
	It is claimed by the Complainant that progress of the project is not at all	
	according to the assurance and the timeline as agreed between the parties and	

till date only some pillars have been erected on the site of the project.

The Complainant prays order for refund of entire payment made by him alongwith admissible interest and compensation as per law.

The Ld. Advocate of the Respondent submitted at the time of hearing that they will submit the Written Response to the Complaint Petition on Affidavit. He also agitated that the Complainant did not file any cancellation request to the Respondent Company.

He also offered to deliver the Complainant an alternate flat which is ready to deliver and having equal facilities.

After hearing both the parties, this Authority is satisfied to proceed for further hearing in terms of Rule 36(2)(e) of WBHIRA Rules, 2018 and accordingly Complainant is directed to send a copy of the signed Complaint petition and self attested photo copies of supporting documents e.g Advertisement of the project, brochure of the project, allotment letter, General Terms and Conditions, Agreement for Sell, all money receipts, correspondences between the parties and/or any other related documents which she has in his possession, to the Authority by speed post and also via email with copy of the same to the Respondent in the same way, within one week from the date of receipt of this order via email.

The Respondent is directed to submit Written Response to the Complaint Petition on Affidavit, containing the Refund Schedule with Specific Dates and Amount of refund and also specific proposal for alternate flat, if any, with equal facilities which they intend to offer to the Complainant, by email and also by speed post to this end and send a copy of the same to the Complainant in the same way, within three weeks from the date of receipt of this order by mail.

Fix 23/09/2020 for further hearing and orders in this matter.
