accordingly following orders are passed:

Ordered,

that the Respondent shall refund the balance principal amount i.e, Rs.3,75,000/- along with interest at the rate of 3.50% per annum as per prevailing savings bank account interest rates for SBI on Rs.5 lakhs from the date of deposit till the date of this final order i.e, 06/02/2020. The total amount refundable in terms of this order as calculated as on 06/02/2020 shall be paid by bank transfer in the bank account of the Complainant within 45 days from the date of receipt of this final order.

Be it noted that Respondent shall pay interest at the rate of SBI PLR+2% in terms of provisions of Rule 18 of WBHIRA Rules, 2018 on any amount remaining outstanding beyond the 45 days from the date of receipt of this order.

Proposals of Respondent for instalment payment by 10/06/2020 are considered and noted that these do not require any further orders in view of the final order which provides for adequate time for refund without any further interest on outstanding as on day and any further delay which Respondent is compelled to resort shall attract the higher rate of interest as per provisions of the law.

Complainant petition is thus disposed off.

Communicate this order to both the parties.

There is no other order as to costs and compensation.
