	Respondent is absent despite due service of notice. Let the service return to	
	be kept on record.	
	Heard the Complainant in detail.	
	Complainant submitted that no refund has been made by the Respondent	
	till date and no initiative has been taken by the Respondent to amicably settle	
	schedule of refund by mutual discussion with the Complainant.	
	After hearing the Complainant and taking into the consideration the	
	documents and evidences on record, the Authority is of the considered view	
	that the Respondent has made default towards his obligations to the	
	Complainant. He received total money of Rs. 6,99,968/- (Rupees six lakhs	- 5
	ninety nine thousand nine hundred and sixty eight) only from the	
	Complainant but failed to deliver the possession within the time period of two	
	years from the date of allotment as mutually agreed between the parties. As	
	per the Complainant no substantial construction took place in the project site	
	and no communication has been made by the Respondent about the status and	

progress of the construction. Therefore, the respondent is liable to refund the total money paid by the Complainant along with interest as per the provisions of WBHIRA Act, 2017 and rules made thereunder.

Hence it is ordered,

that the Responded shall refund to the Complainant of Rs. 6,99,968/- (Rupees six lakhs ninety nine thousand nine hundred and sixty eight) only along with interest @ SBI PLR Plus 2% for the period starting from the date of payment by the Complainant till the date of refund by the Respondent. The refund shall be made by Bank Transfer to the Bank Account of the Complainant within 45 days from the date of receipt of this order.

Complainant is directed to provide his Bank A/c. details, in which he will receive the refund amount, to the Respondent by email, within 3 days from the date of receipt of this order within the stipulated time period.

Complainant is at liberty to make an application to the Authority for execution of this order, if the respondent fails to make the refund as per this order.

With these directions, the matter is hereby dispose of.
