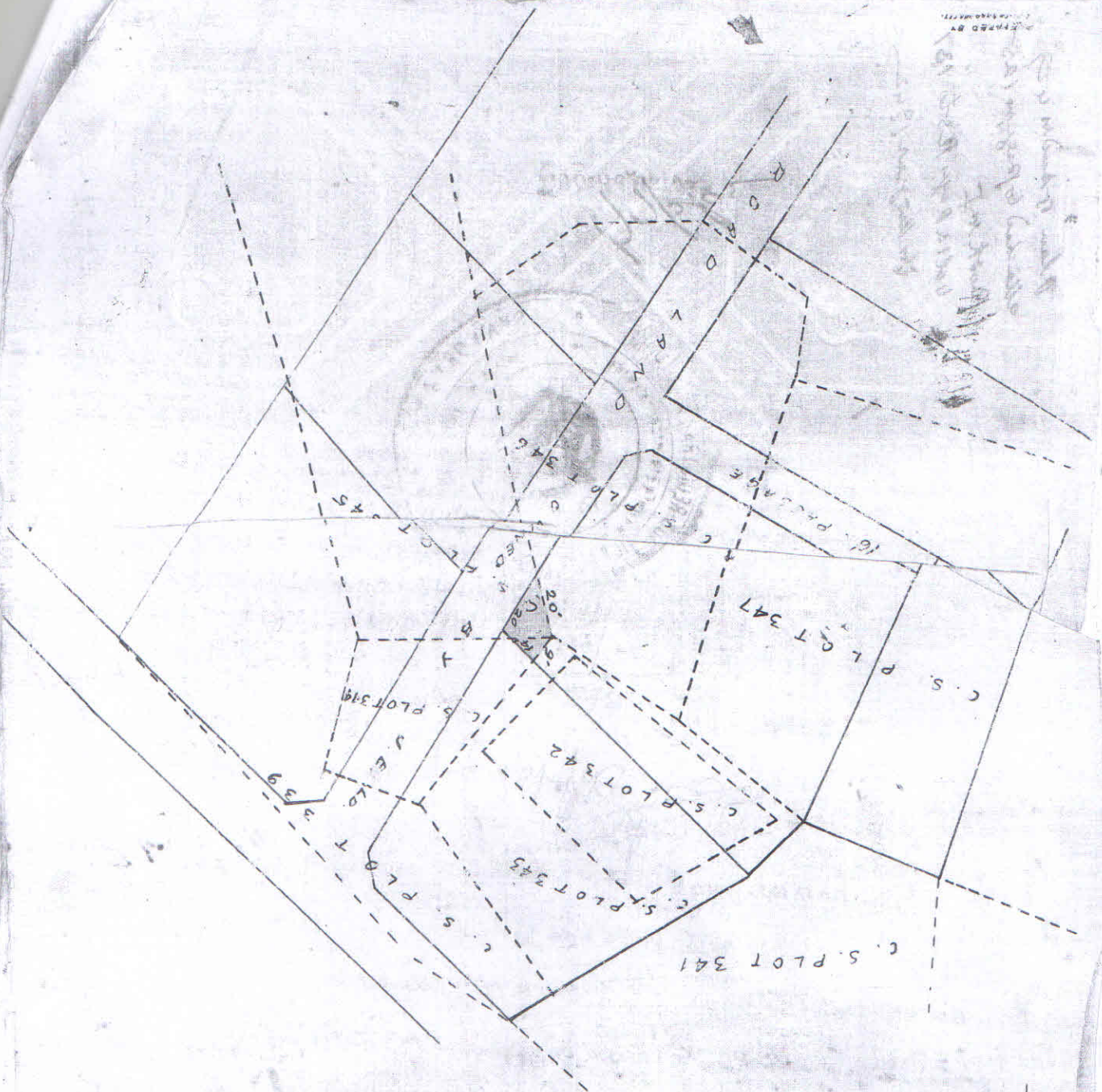

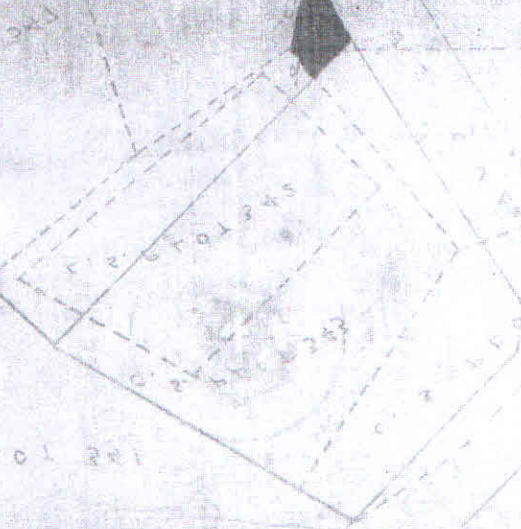
SITE PLAN OF A PLOT OF LAND
