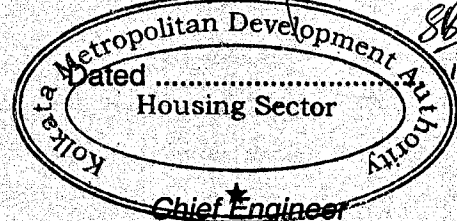

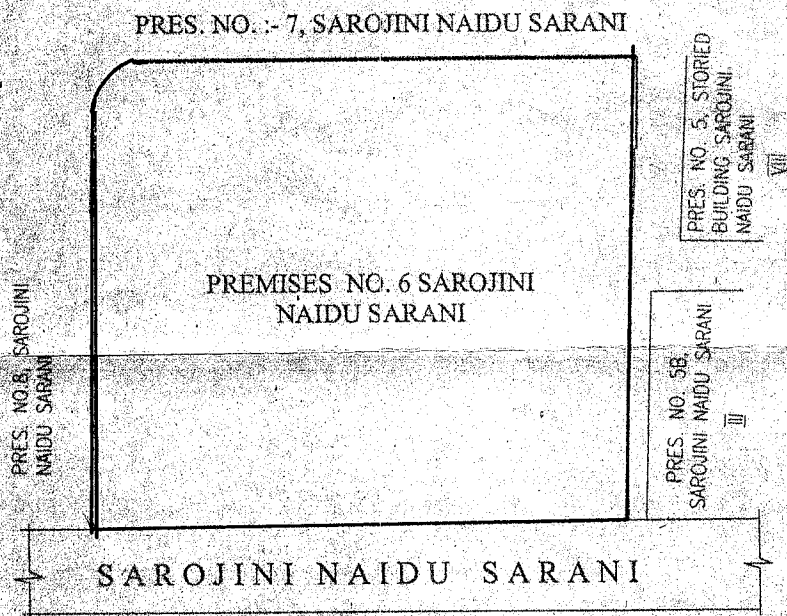

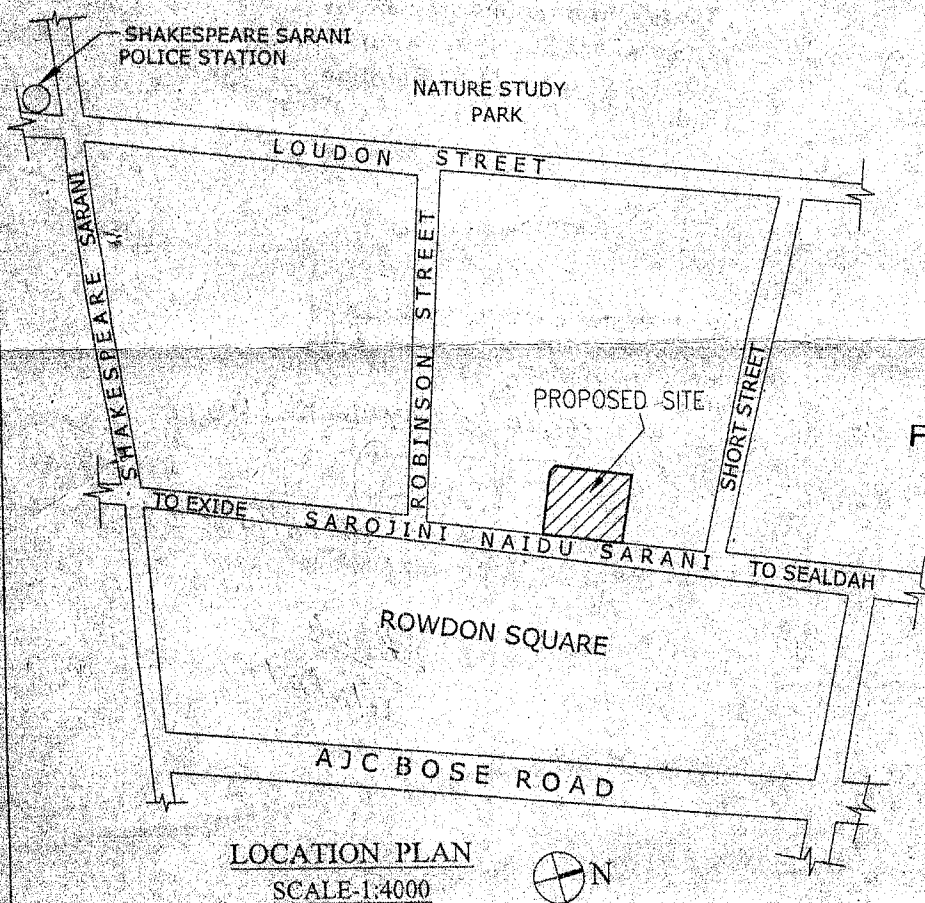
**SITE PLAN OF PREMISES NO. 6 SAROJINI NAIDU SARANI,
