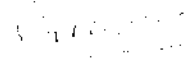

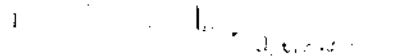

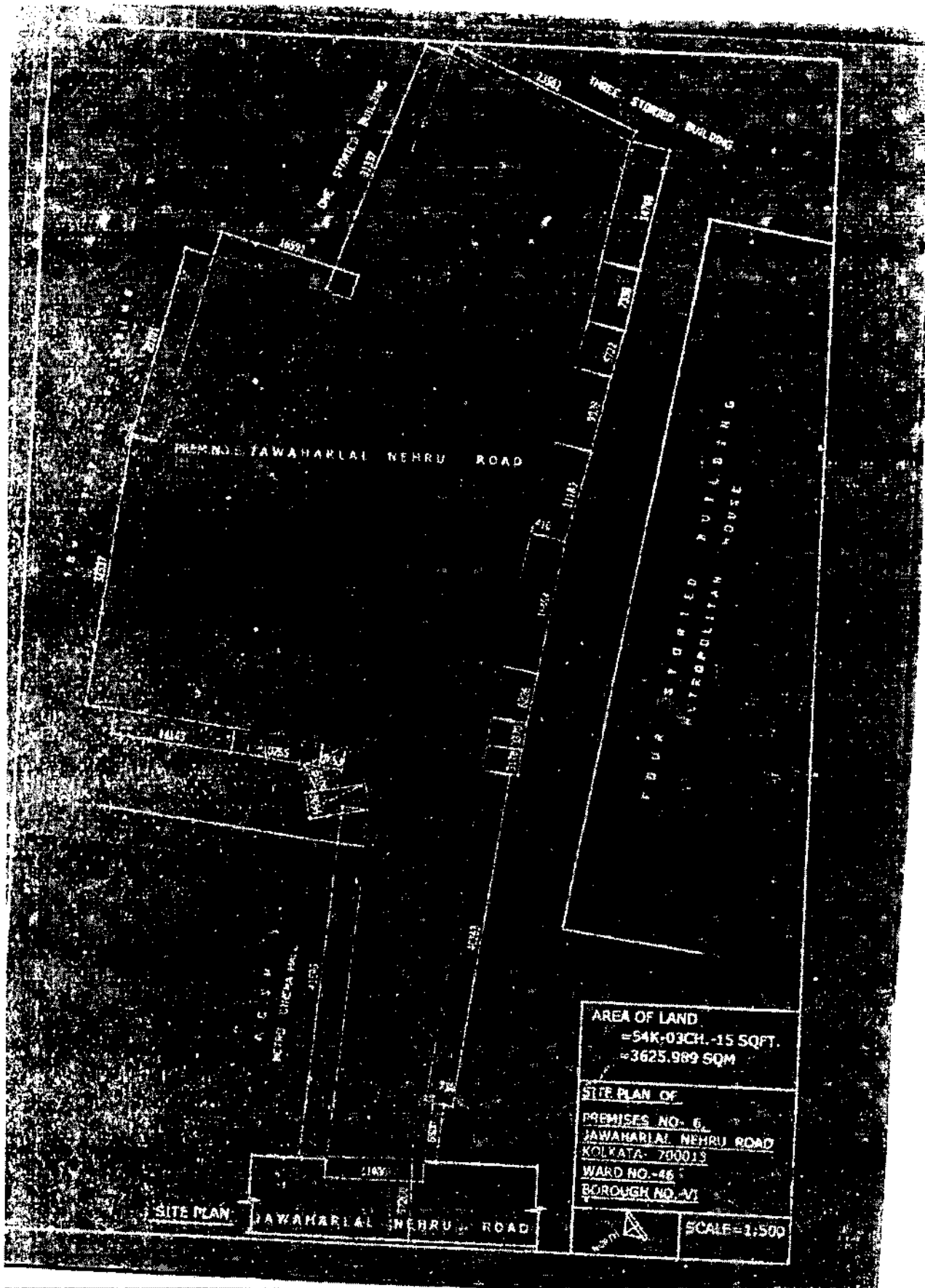

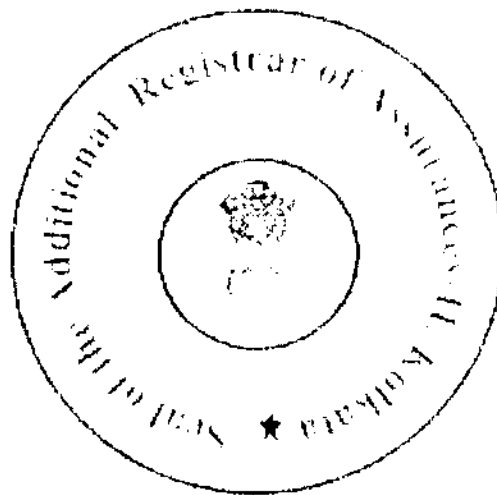
SITE PLAN OF
