



- Demise of Sadhana Rani Baishya: Sadhana Rani Baishya, a Hindu, governed 5.1.2 by the Dayabhaga school of Hindu Law, died intestate leaving behind her surviving, 2 (two) sons, namely, (1) Dulal Baishya and (2) Utpal Baishya and 4 (four) daughters, namely, (1) Swapna Das (2) Rama Dey (Vendor hereinabove) (3) Mita Ghosh and (4) Iti Dutta, who jointly and in equal shares inherited the right, title and interest of Late Sadhana Rani Baishya in Sadhana's Property, free from all encumbrances. The Said Property is the 1/6th portion of Sadhana Rani Baishya's share in the Sadhana's Property and also the subject matter of this conveyance.

- 5.1.3 Absolute Ownership of Vendor: In the circumstances mentioned above, the Vendor has become the undisputed and absolute owner of the Said property, free from all encumbrances.




