2. This registration is granted subject to the following conditions, namely:-

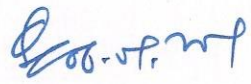
- (i) The promoter shall enter into an agreement for sale with the allottees as provided in 'Annexure A';

- (iv) The registration shall be valid for a period of **2.6** years commencing from **06/09/2019** and ending with **31/03/2022** unless renewed by the Housing Industry Regulatory Authority in accordance with section 6 of the Act read with rule 7 of these rules;

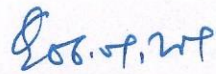
